Order

WHEREAS in terms of Section 14(1) of the NCTE Act, 1993 Al-Momin College of Education, At/Po-Bishunpura, Via-Chirki Bazar, Dist-Gaya, Bihar-824237 has submitted an application to the Eastern Regional Committee of NCTE for grant of recognition for starting B.Ed. Course of one year duration with an annual intake of 100 (one hundred) students.


- 2. AND WHEREAS on scrutiny of the application submitted by the institution, the documents attached therewith, the affidavit and the input received from the visiting team in the form of report and videography, the Committee is satisfied that the institution / society fulfills the requirements under the provisions of NCTE Act, Rules and relevant Regulations including the Norms and standards for the Secondary teacher education programme such as instructional facilities, infrastructural facilities, library, accommodation, financial resources, laboratory etc. for running the programme and has selected / appointed duly qualified teaching staff as per NCTE norms.
- 3. NOW, THEREFORE, in exercise of the powers vested under Section 14(3)(a) of the NCTE Act, 1993, the Eastern Regional Committee hereby grants recognition to Al-Momin College of Education, At/Po-Bishunpura, Via-Chirki Bazar, Dist-Gaya, Bihar-824237 for conducting B.Ed. Course of one year duration from the academic session 2006-2007 with an annual intake of 100 (one hundred) students. The institution shall ensure fulfillment of the following:
 - a) The institution shall maintain the teaching staff strength of a Principal and 07 (seven) faculty members duly qualified as per NCTE norms for the proposed B.Ed. course with an intake of 100 students.
 - b) The institution shall note that with regard to NET/SLET requirement or alternative qualifications thereto as prescribed by UGC from time to time for faculty, the relaxation is allowed before the commencement of the academic session 2009-2010 as per the NCTE Regulations notified on 21.7.2006.
 - c) The institution shall pay salary to the faculty/ staff as prescribed by UGC/ State Govt.
 - d) The institution shall, within one month of the receipt of recognition order, convert the endowment fund account into a joint account to be operated along with an official of the Eastern Regional Committee.

- e) The Reserve Fund for an amount of Rs. 3.00 lakh be maintained in the form of FDR in favour of the management/institution.
- f) The institution shall maintain & update the Web-site as per provisions of NCTE Regulations.
- g) The institution shall adhere to various others regulations, guidelines, norms and standards notified by NCTE from time to time.
- 4. Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC and the State Government etc, wherever applicable.
- 5. The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- 6. If the institution contravenes any of the above conditions or any of the provisions of the NCTE Act, Rules, Regulations and Orders made or issued there under, the Eastern Regional Committee may withdraw the recognition under the provisions of Section 17(1) of the NCTE Act.


