### **ORDER**

WHEREAS, Magadh Teacher's Training College, West Church Road, Near D.M. Residence, Dist – Gaya, Bihar – 823001 (APE00422) was granted recognition for B.Ed. course with an intake of 100 from the academic session 2008-2009 vide order dated 30.04.2008, followed by revised recognition order dated 31.05.2015 with an intake of 100 (two basic units) from the academic session 2015-2016 as per NCTE Regulations, 2014 subject to fulfilment of the conditions in respect of enhancement of additional built up area, additional infrastructure, additional fund, additional staff, maintain and update website and to comply the same to the ERC.

- 2. AND WHEREAS, the ERC in its 254<sup>th</sup> meeting held on 16<sup>th</sup> 17<sup>th</sup> April, 2018 considered the matter and accordingly, a Show Cause Notice under section 17(1) of NCTE Act 1993 was issued on 20.04.2018 to the institution on the following grounds:
  - a. Approved faculty list (current) by the concerned affiliating body along with requisite documents.

b. Approved building plan by the concerned competent Govt. Engineer/Authority.

c. Approved building completion certificate by the concerned competent Govt. Engineer/Authority.

d. FDRs towards Endowment fund and Reserve fund after conversion into joint operation mode as

prescribed in the NCTE Regulations, 2014.

e. Confirmation on website updates of the institutions with all details along with affidavit.

3. AND WHEREAS, institution submitted reply dt.05.05.2018, dt.21.05.2018 & dt.24.06.2019 received on 08.05.2018, 28.05.2018 & 01.07.2019 respectively in compliance to Show Cause Notice. The ERC in its 275<sup>th</sup> held on 27<sup>th</sup> July, 2019 considered the matter and accordingly, another Show Cause Notice under section 17(1) of NCTE Act 1993 was issued on 02.09.2019 to the institution on the following grounds:-

i. Building plan in small font and not approved by competent Govt. Engineer.

ii. Building completion certificate is not in NCTE prescribed proforma and not approved by competent Govt. Engineer.

iii. The validity of FDRs Rs.5 lakh and Rs.3 lakh in single mode expired, which need to be renewed in joint mode. Another FDR of Rs.4 lakh is in single mode.

4. AND WHEREAS, the ERC in its 279<sup>th</sup> meeting held on 14<sup>th</sup> – 16<sup>th</sup> February, 2020 considered the matter along with the reply dated 14.08.2019 received on 19.08.2019 & dated 26.08.2019 received on 29.08.2019 submitted by the institution in response to Show Cause Notice and observed as under:-

i. Photocopy of Building Plan (BP) is not legible and not approved by the competent Govt. Engineer.

ii. Total land area and built up area mentioned in the Building Completion Certificate (BCC) is 32 decimal and 12400 Sq. ft., which is less than required as per NCTE Regulation, 2014.

iii. Original FDRs of Rs.5 lakh & Rs. 7 lakh has not submitted as per NCTE Regulation, 2014.

Hence, B.Ed. course is withdrawn under section 17(1) of NCTE Act, 1993 from the next academic session 2020-21.

- 5. NOW THEREFORE, recognition granted to Magadh Teacher's Training College, West Church Road, Near D.M. Residence, Dist Gaya, Bihar 823001 (Code No. APE00422) for B.Ed. Course is hereby withdrawn in terms of 17(1) of NCTE Act, 1993 with effect from the academic session 2020-2021.
- 6. Further, if the institution is not satisfied by the order, they can prefer an appeal Under Section 18 of the NCTE Act in the "Online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of the issue of the order.
