Order

In terms of Section 14(1) of the NCTE Act, 1993 Department of Education, Patna Women's College. Bailey Road, Patna — 800 001 had submitted an application to the Eastern Regional Committee of NCTE for grant of recognition for B.Ed. course of one year duration from the academic session 2004-2005 with an annual intake of 100 (one hundred) students.

- 2. On scrutiny of the application submitted by the institution, the documents attached therewith, the inputs received from the visiting team, the Committee has noted the following:
 - i. The institution has acquired the land for setting up the teacher education institution.
 - ii. The institution has constructed the building for conducting the course on the above mentioned land
 - iii. The institution has selected One Head and 07 (Seven) lecturers for the said course
- 3. Now, therefore, in exercise of the powers vested under Section 14(3) (a) of the NCTE Act, 1993, the Regional Committee hereby grants recognition to Department of Education, Patna Women's College, Bailey Road, Patna 800 001 for (B.Ed.) Course of one year duration from the academic session 2005-2006 an annual intake of 100 (one hundred) students subject to fulfillment of the following conditions:
 - a. The institution shall ensure that the Principal and 07 (seven) faculty members duly qualified as per NCTE norms are in position for an intake of 100 students and a report to this effect shall be sent to the Eastern Regional Committee within one month of the commencement of the academic session.
 - b. The institution shall appoint non-teaching staff as per the norms of the concerned Government/ Affiliating University/ UGC. and shall submit the list of teaching staff duly countersigned by the competent authority of the University within one month of commencement of the course.
 - c. The institution shall pay salary to the teaching staff as prescribed by UGC. / State Govt.
 - d. The tuition fees shall be charged at rates as prescribed by the concerned State Govt./ Affiliating University.
 - e. The institution shall, within one month of the receipt of recognition order, convert the endowment fund account into a joint account to be operated along with an official of the Eastern Regional Committee.
 - f. The institution shall comply with the various other norms and standards prescribed in the NCTE regulations.

- 4. Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC, the State Government etc.
- **5.** The institution shall submit to the Regional Committee a Performance Appraisal Report at the end of each academic year along with a copy of the approval of the affiliating University to the appointment of faculty members, and the statement of annual accounts duly audited by a Chartered Accountant.
- 6. If the institution contravenes any of the above conditions or any of the provisions of the NCTE Act, Rules, Regulations and Orders made or issued thereunder, the Regional Committee may withdraw the recognition under the provisions of Section 17(1) of the NCTE Act.
