ORDER

WHEREAS, S.M. Zaheer Alam Teacher Training College, Bahera, Darbhanga, Bihar-847201 (APE00506) was granted recognition for B.Ed. course with an intake of 150 from the academic session 1998-1999 vide ERC Order No.6268 dated 22.06.1998, followed by revised order vide No.32606 dated 31.05.2015 from the academic session 2015-2016 as per NCTE Regulations, 2014 subject to fulfilment of the conditions in respect of enhancement of additional built up area, additional infrastructure, additional fund, additional staff, maintain and update website and to comply the same to the ERC.

- 2. AND WHEREAS, the ERC in its 267^{th} meeting held on 10^{th} 11^{th} February, 2019 considered the matter and show cause notice u/s 17(1) was issued on 21.02.2019 to the institution to comply the conditions mentioned in the revised recognition order.
- 3. **AND WHEREAS**, a letter of complaint vide Ref. No.BSU/34/2018/794/GS(I) dated 06.03.2019 issued from the Governor's Secretariat, Bihar, Raj Bhawan, Patna-22 against 16 recognised B.Ed. Teacher Education Institutions in the State of Bihar affiliated to different Universities received through NCTE HQrs. vide letter No.NCTE-Reg.1011/11/2019-US(Regulation)-HQ/78664 dated 16.05.2019 for necessary action as per NCTE Act/Regulations by placing the matter before the ERC as these institutions have failed to upload photographs of faculty and students by means of which created suspicion about their conduct and quality of teachers.
- 4. **AND WHEREAS**, the ERC in its 272^{nd} meeting held on $30^{th} 31^{st}$ May & 1^{st} June, 2019 considered the matter and show cause notice u/s 17(1) was issued on 18.06.2019 to the institution to comply fulfilment of conditions mentioned under Clause 7(14)(i) of NCTE Regulations, 2014 and display the same on their official website.
- 5. **AND WHEREAS**, the ERC in its 275th Meeting held on 27th July, 2019 considered the matter along with the reply dated 03.07.2019 submitted by the institution in response to Show Cause Notice and the institution is still deficient on the following grounds:-
 - (i) Faculty list submitted dated 11.03.2019 is not in NCTE prescribed proforma and not approved from affiliating body.

(ii) Building completion certificate is not in NCTE prescribed proforma.

(iii) Building plan is not approved by competent Govt. Engineer

Recognition granted to B.Ed. course is withdrawn under section 17(1) of NCTE Act, 1993 from the academic session 2020-2021.
