ORDER

WHEREAS, in terms of Section 14(1) of the NCTE Act, 1993, Magadh University, Bodh Gaya, Dist. - Gaya, Bihar - 824234 has applied for grant of recognition for B.Ed. Course (Code No. APE00536) was received by Eastern Regional Committee of NCTE on 23.08.2005.

- 2. AND WHEREAS, on scrutiny of the application submitted by the institution, the documents attached therewith, the affidavit submitted and the report received from VT and videography, and the certificates received from the affiliating body, the Committee is satisfied that the applicant fulfils the requirements under the provisions of NCTE Act, Rules and relevant Regulations including the Norms and Standards for the said teacher education programme such as instructional facilities, infrastructural facilities, financial resources, etc., for running the programme.
- 3. AND WHEREAS, as per the decision of 75th ERC Meeting formal recognition order was issued vide No. ERC/7-75.6(I).8/2007/7916 dated 03.05.2007 for conducting B.Ed. course with an intake of 100 (One hundred) to the institution.
- 4. AND WHEREAS, the Chairperson, NCTE, New Delhi had constituted a Committee for inspection of the B.Ed. institutions in Bihar as per direction of the Hon'ble High Court of Patna vide order 19.01.2010 in connection with CWJC No. 13927 of 2009. Accordingly, the Committee conducted the inspection of institutions including this institution during the period from February, 2010 to May, 2010.

The ERC in its 165^{th} meeting held on $5^{th} - 6^{th}$ December, 2013 considered the matter and as decided, a Notice dated 17.12.2013 was issued to the institution on the following grounds:

- (i) Clarification u/c 17 was issued to the principal on 21.08.2013.
- (ii) In response to the said clarification, the institution vide representation dated 21.09.2013 requested one month time for appointment of the new principal.
- (iii) The Committee accepted the request of the university and allowed 30 days more time to compliance the clarification issued u/c 17.
- (iv) The institution is required to submit a fresh faculty list adding the name of the newly appointed principal duly approved by the Registrar of the university.

Reply in response to ERC's Notice dated 17.12.2013 has not been received till date and the institution is still deficient on the above grounds.

In view of the above, the Committee decided as under:

The Committee is of the opinion that recognition granted to B.Ed. course of the application bearing Code No. APE00536 is withdrawn under section 17(1) of NCTE Act, 1993 from the next academic session.

- 5. NOW, THEREFORE, grant of recognition to Magadh University, Bodh Gaya, Dist. Gaya, Bihar 824234 (Code No. APE00536) for B.Ed. Course vide Order No. ERC/7-75.6(I).8/2007/7916 dated 03.05.2007 is hereby withdrawn in terms of section 17(1) of NCTE Act, 1993 from the next academic session.
- 6. Further, if the institution is not satisfied with the order, they can prefer an appeal under Section 18 of the NCTE Act in the "Online mode" available at NCTE's website www.ncte-india.org within 60 days from the date of issue of the order.
