**ORDER**

**AND WHEREAS**, the institution was granted recognition for conducting B.Ed. course vide order No. ERC/7-80.13.5/2007/9476 dated 10.10.2007 with an intake of 100 (One hundred) by the ERC, NCTE, followed by revised order issued vide No. 32649 dated 31.05.2015 as per NCTE Regulations, 2014.

2. **AND WHEREAS**, the ERC in its 244th ERC Meeting held on 08<sup>th</sup> – 09<sup>th</sup> October'2017, as decided recognition granted to B.Ed. course was withdrawn under section 17(1) of NCTE Act, 1993 from the next academic session vide ERC order No.ER-244.17.13/APE00798/B.Ed./2017/ 54751 dated 20.10.2017.

3. **AND WHEREAS**, the institution preferred an appeal to NCTE HQs. and the Appellate Authority vide order No.89-734/E-48827/ 2017-Appeal/2nd Mtg.-2018/3rd & 5th Feb., 2018 dated 16.03.2018 decided to set aside the withdrawal order. Appellant institution is required to submit to ERC copy of faculty lists approved by affiliating body within 15 days of the issue of Appeal orders.

4. **AND WHEREAS**, this matter was placed before ERC time to time and Show Cause Notices were issued on 10.05.2018, 07.06.2018, 03.08.2018 and finally on 21.02.2019 in view of the Court Order dated 24.08.2018 passed by the Hon'ble High Court of Patna received from the institution. Reply from the institution dated 18.02.2019 considered by the ERC in its 268<sup>th</sup> (Part-I) meeting held on 24<sup>th</sup> February'2019.

**In view of the above, the Committee decided as under:-**

Formal recognition order under clause 7(16) of the NCTE Regulation 2014 for **B.Ed. programme** with an intake **100 (two basic units)** with effect from the academic session **2019-2020** be issued to the institution.

5. **NOW THEREFORE**, in exercise of the powers vested under Section 14(3)(a) of the NCTE Act 1993, the Eastern Regional Committee, NCTE hereby grants recognition to **Veerayatan B.Ed. College, Pawapuri, Dist-Nalanda, Bihar-803116** for conducting **B.Ed. Course** of two years duration with intake of **100 (Two Basic Units)** with effect from the academic session **2019-2020** under Clause 7(16) of NCTE (Recognition Norms & Procedure) Regulations, 2014 subject to fulfillment of the following conditions:-

1. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Loan raising against or mortgaging of FDRs shall not be done.

- II. The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.
- III. The institution shall make admission only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations 2014.
- IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.

4. Further, the recognition/permission is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University / Body, the State Government etc., as applicable.

5. The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.

6. The institution shall maintain its website with hyperlink to the Council and the Eastern Regional Committee, covering, inter-alia, the details of the institution, its location, name of the programme applied for with intake; availability of physical infrastructure, such as land, building, office, classrooms and other facilities or amenities; instructional facilities, such as laboratory and library and the particulars of their proposed teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website, namely:-

- a. Sanctioned programme along with annual intake in the institution;
- b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph;
- c. Name of faculty members who left or joined during the last quarter;
- d. Names of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;
- e. Fee charged from students;
- f. Available infrastructural facilities;
- g. Facilities added during the last quarter;
- h. Number of books in the library, journals subscribed to, and additions, if any, in the last quarter;
- i. The affidavit with enclosure submitted along with application;
- j. The institution shall be free to post additional relevant information, if it so desires.
- k. Any false or incomplete information on its website shall render the institution liable for withdrawal of recognition.

7. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.

8. The institution shall make available list of students admitted on its official website.

9. The Educational Institution shall follow Uniform Accounting System as brought out by ICAI and accepted by MHRD.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made and issued there under, the institution will render itself liable to adverse action including withdrawal of recognition / permission by the Regional Committee under the provisions of Section 17(1) of the NCTE Act.
