<u>ORDER</u>

WHEREAS, Siddhartha Teacher's Training College, Vill./PO.-Jehanabad, Dist.-Jehanabad, Bihar-804408 (Code No. APE01024) was granted recognition for B.Ed. course with an intake of 100 from the academic session 2013-2014 vide ERC Order No. 1047 dated 05.08.2009, followed by revised order vide No. 32558 dated 30.05.2015 from the academic session 2015-2016 as per NCTE Regulations; 2014 subject to fulfilment of the conditions in respect of enhancement of additional built up area, additional infrastructure, additional fund, additional staff, maintain and update website and to comply the same to the ERC.

- 2. **AND WHEREAS**, the ERC in its 268^{th} meeting held on 24^{th} 25^{th} February, 2019 considered the matter and as decided, Show Cause Notice u/s 17(1) was issued on 11.03.2019 to the institution on the following grounds:
 - (i) In the submitted faculty list at sl. No. Shri Upendra Kumar Possess 52% percentage of marks in master degree in school subject, which is less than required as per NCTE Regulations, 2014.
 - (ii) Validity of fire safety certificate has been expired.
- 3. AND WHEREAS, the matter was placed before the committee in its 275th ERC meeting held on 27th, 2019 considered the matter along with the reply dtd. 18.03.2019 submitted by the institution in response to the SCN dtd. 11.03.2019 and observed as under:
- > Show cause notice u/s 17(1) issued on 11.03.2019, followed by a letter dated 22.05.2019 with the following to comply within 21 days:-
 - (i) The recognition granted to the institution will continue subject to submission of a fresh faculty countersigned by registrar of the affiliating University mentioning the correct marks of one faculty viz. Shri Upendra Kumar.

Reply dated 13.07.2019 received seeking extension of time, which is not accepted by the Committee.

The institution is still deficient on the ground mentioned in the letter dated 22.05.2019.

Recognition granted to B.Ed. course is withdrawn under section 17(1) of NCTE Act, 1993 from the academic session 2020-2021. \uparrow
