(ERCAPP1075) was granted recognition for conducting B.Ed. course from time to time with an intake of 100 from the academic session 2012-2013 vide ERC order dated 26.05.2015, followed by revised order dated 26.05.2015 from the academic session 2015-2016 as per NCTE Regulations, 2014 subject to fulfilment of the conditions in respect of enhancement of additional built up area, additional infranstructure, additional fund, additional staff, maintain and update website and to comply the same to the ERC.

- 2. **AND WHEREAS,** the ERC in its  $274^{th}$  meeting held on  $15^{th}$   $16^{th}$  July, 2019 considered the matter that 1st show cause notice u/s 17(1) issued on 27.11.2018, followed by final show cause notice dated 16.05.2019 and the institution is still deficient on the following ground:-
  - (i) Faculty list comprises 1+12 instead of 1+15 as per NCTE Regulations, 2014.

The intake for **B.Ed. course** be **reduced from 100 to 50 from the academic** session 2020-2021 with intimation to the institution and all concerned.
