ORDER

WHEREAS, S. R. Teacher Training College, Plot No. 337, 338, 339, 340, 341, 68, 352, Vill. – Line Bazar, Po. – Line Bazar, Tehsil/Taluka– Meer Ganj, Town/City – Meer Ganj, Dist. – Gopalganj, Bihar – 841438 (ERCAPP1080) was granted recognition for B.Ed. course with an intake of 100 (two basic units) from the academic session 2012-2013 vide ERC Order No. 13732 dated 29.08.2012, followed by revised order vide No.31955 dated 23.05.2015 from the academic session 2015-2016 as per NCTE Regulations, 2014 subject to fulfilment of the conditions in respect of enhancement of additional built up area, additional infrastructure, additional fund, additional staff, maintain and update website and to comply the same to the ERC.

- 2. **AND WHEREAS**, the ERC in its 267^{th} Meeting held on $10^{th} 11^{th}$ February, 2019 considered the matter and as decided, Show Cause Notice u/s 17(1) was issued on 22,02,2019 to the institution.
- 3. **AND WHEREAS**, the ERC in its 271st Meeting held on 24th -25th April, 2019 considered the matter along with the reply dated 14.03.2019 submitted by the institution in response to SCN and Final Show Cause Notice u/s 17(1) was issued on 14.05.2019 to the institution on the following grounds:-
 - (i) Building completion certificate in accordance with NCTE prescribed proforma signed by competent Govt. Engineer is not submitted.
 - (ii) Total built up area mentioned in the building plan as 1545.50 Sq.Mts., which is less for running two units (100 intakes) of B.Ed. course as per NCTE Regulations, 2014.
- 4. **AND WHEREAS**, the ERC in its 274^{th} Meeting held on 15^{th} 16^{th} July, 2019 considered the matter along with the reply dated 04.06.2019 from the institution in response to final show cause notice and the institution is still deficient on the following grounds:-
 - (i) Building plan is not approved by competent Govt. Authority.

(ii) Total built up area in building plan is 1545.50 Sq. Mts.

- (iii) The old building plan signed in 2011 has been countersigned by B.C.D., J.E., Gopalganj without any proof of addition/modification of the plan.
- (iv) While submitting the information, the column on roofing category has been left blank.
- (v) No documentary evidence about addition/modification in the built up area has been provided.

In view of the above, the Committee decided as under:
Recognition granted to B.Ed. course is withdrawn under section 17(1) of NCTE Act,
1993 from the academic session 2020-2021.
