ORDER

WHEREAS, Ramkrishna College, Plot No.1538, 1539, 1540, 1541, 1542, 1543, Vill-College Road, Po-Madhubani, Tehsil/Taluka-Rahika, Town/City-Madhubani, Dist-Madhubani, Bihar-847211 was granted recognition for B.Ed. course with an intake of 100 from the academic session 2014-2015 vide order dated 31.08.2013, followed by revised order dated 23.05.2015 with an intake of 100 (two basic units) from the academic session 2015-2016 as per NCTE Regulations, 2014 subject to fulfilment of the conditions in respect of enhancement of additional built up area, additional infrastructure, additional fund, additional staff, maintain and update website and to comply the same to the ERC.

- 2. **AND WHEREAS**, the ERC in its 274th meeting held on 15th 16th July'2019 considered the matter and observed that 1st Show Cause Notice u/s 17(1) issued on 18.12.2018. Final Show Cause Notice issued dated 16.05.2019 in the compliance matter of revised recognition order, followed by another Show Cause Notice dated 18.06.2019 on the basis of complaint from the Governor's Secretariat and the institution is still deficient on the following grounds:
 - i. Faculty list approved by the concerned affiliating body is not submitted. No reply received.
 - ii. Reply of SCN dated 18.06.2019 is not satisfactory as the institution did not comply fulfilment of conditions mentioned under Clause 7(14)(i) of NCTE Regulations, 2014 and display the same on their official website.

In view of the above, the Committee decided as under:-

The Committee is of the opinion that recognition granted to **B.Ed. course** is **withdrawn** under section 17(1) of NCTE Act, 1993 from the academic session 2020-2021.

3. NOW THEREFORE, recognition granted to Ramkrishna College, Plot No.1538, 1539, 1540, 1541, 1542, 1543, Vill-College Road, Po-Madhubani, Tehsil/Taluka-Rahika, Town/City-Madhubani, Dist-Madhubani, Bihar-847211 (Code No.ERCAPP1123) for B.Ed. Course is hereby withdrawn in terms of 17(1) of NCTE Act, 1993 from the academic session 2020-2021.
