- AND WHEREAS, on scrutiny of the application submitted by the institution, the documents attached therewith, the affidavit submitted and the report received from VT, video and the certificates received from the affiliating body, the Committee is satisfied that the applicant fulfils the requirements under the provisions of NCTE act, Rules and relevant Regulations including the Norms and Standards for the said teacher education programme such as instructional facilities, infrastructural facilities, financial resources, etc., for running the programme.
- AND WHEREAS, recognition was granted for B.Ed. course with an intake of 100 from the academic session 2012-2013 vide ERC Order No.12717 dated 20.07.2012, followed by revised order vide No.31986 dated 23.05.2015 from the academic session 2015-2016 as per NCTE Regulations, 2014 subject to fulfilment of the conditions in respect of enhancement of additional built up area, additional infrastructure, additional fund, additional staff, maintain and update website and to comply the same to the ERC.
- AND WHEREAS, the Committee considered the matter in its meetings held time to time along with the reply dated 15.02.2019 submitted by the institution in response to Show Cause Notice and observed as under:-

Show Cause Notices were issued on 27.11.2018 and 24.01.2019.

Faculty comprising 10 (05 full-time + 05 part-time) instead of 1+15 as per (i) NCTE Regulations, 2014. Part-time faculties are not accepted. (ii)

Building completion certificate in the NCTE prescribed proforma duly approved by Govt. Engineer not submitted.

In view of the above, the Committee decided as under:-

The Committee is of the opinion that recognition granted to **B.Ed. course** of the application bearing Code No. ERCAPP1237 is withdrawn under section 17(1) of NCTE Act, 1993 with effect from the academic session 2019-2020.
