ORDER

WHEREAS, Govt. College of Teacher Education, Samastipur, Plot No.- 1560, 1556P, Street No. Ameerganj, Vill.-Dharampur, PO.-Samastipur, Tehsil/Taluka-Jitwarpur, Town/CitySamastipur, Dist.- Samastipur, Bihar-848101 (Code No. ERCAPP1377) was granted recognition for B.Ed. course with an intake of 100 from the academic session 2014-2015 vide ERC Order No. 23237 dated 17.01.2014, followed by revised order vide No.32088 dated 25.05.2015 with an annual intake of 100 from the academic session 2015-2016 as per NCTE Regulations, 2014 subject to fulfilment of the conditions in respect of enhancement of additional built up area, additional infrastructure, additional fund, additional staff, maintain and update website and to comply the same to the ERC.

- 2. **AND WHEREAS**, the ERC in its 267th meeting held on 10^{th} 11^{th} Feb 2019, considered the matter and as decided, Show Cause Notice u/s 17(1) was issued on 21.02.2019 to the institution on the following grounds:
 - (i) Submitted faculty list comprising of 09 instead of 16 as per NCTE Regulations, 2014. Consolidated faculty list approved by affiliating body is to be submitted.
- 3. **AND WHEREAS**, the ERC in its 272nd Meeting held on 30th, 31st May & 1st June, considered the matter along with the reply dated 08.03.2019 & 11.04.2019 submitted by the institution in response to Show Cause Notice and observed as under:
 - a) Three Show Cause Notice u/s 17(1) were issued on 20.04.2018, 27.11.2018, 17.01.2019.
 - b) Another Show Cause Notice u/s 17(1) was issued dated 21.02.2019 for appointment of requisite number of faculty as per NCTE Regulations, 2014 for running 02 units (100 intake) of B.Ed. course.

c) Faculty list comprises 09 instead of 16 as per NCTE Regulations, 2014.

d) Despite repeated SCN for compliance, the said institution has failed to fulfill the Norms as per NCTE Regulations, 2014.

In view of the above, the Committee decided as under:

The Committee is of the opinion that recognition granted to **B.Ed. course** of the application bearing Code No. ERCAPP1377 is withdrawn under section 17(1) of NCTE Act, 1993 from the academic session 2019-2020.

4. **AND WHEREAS**, an emergent meeting was tool place on 14th June 2019, and it was decided to rectify the year of withdrawn of recognition as per the provision laid down under section 17(1) of the NCTE Act, i.e. withdrawn be made with effect from the end of the academic session next following the date of communication of such order i.e. recognition to B.Ed. course be withdrawn from the academic session 2020-2021 instead of 2019-2020 in all respect and orders be issued accordingly.

College of Teacher Education, Samastipur, Plot No.- 1560, 1556P, Street No. Ameerganj, Vill.-Dharampur, PO.-Samastipur, Tehsil/Taluka-Jitwarpur, Town/CitySamastipur, Dist.- Samastipur, Bihar-848101 (Code No. ERCAPP1377) for B.Ed. Course is hereby withdrawn under section 17(1) of NCTE Act, 1993 with effect from the end of the academic session next following the date of communication of such order i.e. from 2020-2021.
- 6. **FURTHER**, if the institution is not satisfied by the order, they can prefer an appeal Under Section 18 of the NCTE Act in the "Online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of the issue of the order.
