ORDER

WHEREAS, T P College, Madhepura, Plot No. 1769, Street-Road-Madhepura, Vill-PO-City- Madhepura, Tehsil/Taluka-Madhepura, Dist.-Madhepur, Bihar-852113 (Code No. ERCAPP1423) was granted recognition for B.Ed. course with an intake of 100 from the academic session 2014-2015 vide ERC order No. 23870 dated 12.02.2014, followed by revised order vide No.31660 dated 15.05.2015 with an intake of 100 (two basic unit) from the academic session 2015-2016 as per NCTE Regulations, 2014 subject to fulfilment of the conditions in respect of enhancement of additional built up area, additional infrastructure, additional fund, additional staff, maintain and update website and to comply the same to the ERC.

- 2. **AND WHEREAS**, the ERC in its 254th meeting held on 16^{th} 17^{th} April, 2018 considered the matter and as decided, Show Cause Notice u/s 17(1) was issued on 20.04.2018 to the institution on the following grounds:
 - a. Approved faculty list (current) by the concerned affiliating body along with requisite documents.

b. Approved building plan by the concerned competent Govt. Engineer/Authority.

c. Approved building completion certificate by the concerned competent Govt. Engineer/Authority.

d. FDRs towards Endowment fund and Reserve fund after conversion into joint operation mode as prescribed in the NCTE Regulations, 2014.

- e. Confirmation on website updates of the institutions with all details along with affidavit.
- 3. **AND WHEREAS**, a complaint from the Governor's Secretariat, Bihar, Raj Bhawan, Patna-22 vide letter Ref.No.BSU/34/2018/ 794/GS(I) dated 06.03.2019—against 16 recognised B.Ed. Teacher Education institutions in the State of Bihar affiliated to different Universities received through NCTE HQrs. vide letter No.NCTE-Reg.1011/11/2019-US(Regulation)-HQ/78664 dated 16.05.2019 for necessary action as per NCTE Act/Regulations. The ERC in its 272nd Meeting held on 30th 31st May & 1st June, 2019 considered the matter and another Show Cause Notice u/s 17(1) was issued in 18.06.2019.
- 4. **AND WHEREAS**, the ERC in its 274th Meeting held on 15th 16th July, 2019 Recognition granted to B.Ed. course with an intake of 100 from the academic session 2014-2015 vide ERC order dated 12.02.2014, followed by revised order dated 15.05.2015 from the academic session 2015-2016 as per NCTE Regulations, 2014.

- (i) Approved faculty list by the concerned affiliating body along with requisite documents.
- (ii) Approved building plan by the competent Govt. Engineer/Authority.
- (iii) Approved building completion certificate by the competent Govt. Engineer/Authority.
- (iv) FDRs towards Endowment fund and Reserve fund after conversion into joint operation mode as prescribed in the NCTE Regulations, 2014.
- (v) Confirmation on website updates of the institutions with all details along with affidavit.
- (vi) The institution is to comply fulfilment of conditions mentioned under Clause 7(14)(i) of NCTE Regulations, 2014 and display the same on their official website.
- (vii) The institution has failed to comply the deficiencies mentioned in the SCN.

Recognition granted to **B.Ed. course** is **withdrawn** under section 17(1) of NCTE Act, 1993 from the academic session 2020-2021.

- 5. **NOW THEREFORE**, recognition granted to the institution viz. T P College, Madhepura, Plot No. 1769, Street-Road-Madhepura, Vill-PO-City- Madhepura, Tehsil/Taluka-Madhepura, Dist.-Madhepur, Bihar-852113 (Code No. ERCAPP1423) for B.Ed. Course is hereby withdrawn under section 17(1) of NCTE Act, 1993 from the 2020-2021.
- 6. **FURTHER,** if the institution is not satisfied by the order, they can prefer an appeal Under Section 18 of the NCTE Act in the "Online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of the issue of the order.
