ORDER

Change of Premises of the Institution

WHEREAS, Bihar College of Teacher Education, Vill- Samanpura, PO-B.V. College, Dist-Patna, Bihar-800014 (ERCAPP162) granted recognition for conducting B.Ed. course with an intake of 100 vide Order No. ERC/7-130.6(i).9/2012/11168 dated 20.04.2012 as per decision taken in 130th ERC meeting, followed by revised order issued vide No. 31739 dated 20.05.2015 as per NCTE Regulation, 2014.

2. **AND WHEREAS**, the aforesaid institution had submitted application dated 02.06.2016 for shifting of premises along with requisite documents.

3. **AND WHEREAS**, the ERC in its 248th meeting held on 12th - 13th January, 2018 decided that VT be constituted for shifting of premises. Accordingly, the inspection of the institution of new premises was conducted on 14th - 15th April, 2018 and Visiting Team Report received at ERC, NCTE on 23.04.2018.

4. **AND WHEREAS**, the ERC in its 255th meeting held on 30th April to 2nd May, 2018 considered the VT report and as decided, Show Cause Notice was issued on 17.05.2018 to the institution.

5. **AND WHEREAS**, the ERC in its 256th meeting held on 30th - 31st May, 2018 after considering and examining the application along with the documents submitted by the institution, the agenda note, the NCTE Act., the NCTE Regulations 2014 including Norms and Standards, guidelines received from the NCTE Hqs. from time to time, VTR for shifting of premises and reply received in response to SCN after VT, discussed the matter in detail and decided as under:

"Shifting of the institution to its new premises i.e. Bihar College of Teacher Education, Chiraura, Azad Nagar, Naubatpur, Dist.-Patna, Bihar-801109 is permitted".
