WHEREAS in terms of Section 14(1) of the NCTE Act, 1993, K.D. College of Education, Plot No. 32 26, 31, Street No. NH 84, Vill- Parasia, Po.- Dalsagar, Tehsil/Taluka-Buxar, Town/City- Buxar, Dist.- Buxar, Bihar – 802116 has submitted an application (Code No.ERCAPP1716) to the Eastern Regional Committee of NCTE for grant of recognition for conducting **B.Ed.
