ORDER

WHEREAS, K.D. College of Education, Plot No.- 32 26, 31, Street No. NH 84, Vill-Parasia, PO.- Dalsagar, Tehsil/Taluka- Buxar, Town/City-Buxar, Bihar-802116 (ERCAPP1716) was granted recognition for B.Ed. course with an intake of 100 from the academic session 2014-2015 vide ERC Order No. 24418 dated 03.03.2014, followed by revised order vide No. 32639 dated 31.05.2015 from the academic session 2015-2016 as per NCTE Regulations, 2014 subject to fulfilment of the conditions in respect of enhancement of additional built up area, additional infrastructure, additional fund, additional staff, maintain and update website and to comply the same to the ERC.

2. **AND WHEREAS**, the ERC in its 271st meeting held on 24th – 25th April, 2019 considered the matter and as decided, Show Cause Notice u/s 17(1) was issued on 18.05.2019 to the institution on the following grounds:

- (i) Approved faculty list by the concerned affiliating body along with requisite documents.
- (ii) Approved building plan by the concerned competent Govt. Engineer/Authority.
- (iii) Approved building completion certificate by the concerned competent Govt. Engineer/ Authority.
- (iv) FDRs towards Endowment fund and Reserve fund after conversion into joint operation mode as prescribed in the NCTE Regulations, 2014.
- (v) Confirmation on website updates of the institutions with all details along with affidavit.

3. **AND WHEREAS**, the matter was placed before the committee in its 274th ERC meeting held on 15th – 16th July, 2019 for non-compliance of SCN Issued previously on 18.05.2019 and committee took decision as under:

➤ Hence, Recognition granted to B.Ed. course is withdrawn under section 17(1) of NCTE Act, 1993 from the academic session 2020-2021.

4. **NOW THEREFORE**, recognition granted to the institution viz. K.D. College of Education, Plot No.- 32 26, 31, Street No. NH 84, Vill- Parasia, PO.- Dalsagar, Tehsil/Taluka- Buxar, Town/City-Buxar, Bihar-802116 (Code No.ERCAPP1716) for B.Ed. Course is hereby withdrawn under section 17(1) of NCTE Act, 1993 with effect from the academic session 2020-2021.


