ORDER

WHEREAS, Chanakya Foundation, Vill:- Chhitampur, Street/Road: Chanakya Nagar, Taluka/Mandal: Koilwar, Town/City:Chhitampur, Dist: Bhojpur, Bihar-802160 (ERCAPP201646142) (ID No.9858) was granted recognition for B.Ed. course with an intake of 100 (two basic units) from the academic session 2017-2018 vide ERC Order No.53012 dated 02.05.2017.

2. AND WHEREAS, a letter of complaint vide Reference No.BSU/34/2018/2889/GS(I) dated 19.11.2018 issued from Governor's Secretariat, Bihar, Raj Bhawan, Patna-22 against 39 recognised B.Ed. Teacher Education Institutions in the State of Bihar affiliated to the Universities viz. Magadh University, Patliputra University and Maulana Mazharul Haque Arabic & Persian University respectively as mentioned against each institution received in ERC, NCTE from Magadh University vide letter No.GIIIA/407/18 dated 01.12.2018 requesting to take appropriate action against these institutions, which have failed to comply with the direction of Hon'ble Chancellor for ensuring transparent compliance of NCTE recognition norms, University affiliating norms and other provisions as mandated by law.

3. AND WHEREAS, the Eastern Regional Committee in its 264th meeting held on 5th - 6th December, 2018 considered the aforesaid letter of complaint and as decided, the Registrar, Magadh University was intimated vide letter No.58626 dated 12.12.2018 regarding the provisions laid down u/s 14 and u/s16 of NCTE Act, 1993 applicable for the examining bodies in the matter of grant of affiliation or cancellation of affiliation and holding the examination of recognized institutions thereof.

4. AND WHEREAS, a letter vide No.NCTE-Reg1011/11/2019-US(Regulation)-HQ dated 24.01.2019 was received from NCTE Hqrs. enclosing a copy of letter of aforesaid complaint dated 19.11.2018 from the Governor's Secretariat, Bihar, Raj Bhawan, Patna-22 with direction to place the matter before the ERC for appropriate decision for issuing Show Cause Notice to the institutions u/s 17(1) of NCTE Act, 1993.

5. AND WHEREAS, the Eastern Regional Committee in its 266th meeting held on 31st January, 2019 considered again the above matter and as decided, Show Cause Notice u/s 17(1) was issued on 08.02.2019 to the institution on the following grounds:-

- (i) Approved faculty list by the concerned affiliating body along with requisite documents.
- (ii) Approved building plan by the concerned competent Govt. Engineer/Authority.
- (iii) Approved building completion certificate by the concerned competent Govt. Engineer/Authority.

- (iv) FDRs towards Endowment fund and Reserve fund after conversion into joint operation mode as prescribed in the NCTE Regulations, 2014.
- (v) Confirmation on website updates of the institutions with all details along with affidavit.
- (vi) Fire safety certificate issued from the competent Govt. Authority.

6. **AND WHEREAS**, the institution had failed to submit reply in response to SCN dated 08.02.2019 within the stipulated time. The ERC in its 275th meeting (Part-2) held on 27th July, 2019 considered the matter in detail and observed as under:

- (i) Approved faculty list by the concerned affiliating body along with requisite documents.
- (ii) Approved building plan by the concerned competent Govt. Engineer/Authority.
- (iii) Approved building completion certificate by the concerned competent Govt. Engineer/Authority.
- (iv) FDRs towards Endowment fund and Reserve fund after conversion into joint operation mode as prescribed in the NCTE Regulations, 2014.
- (v) Confirmation on website updates of the institutions with all details along with affidavit.
- (vi) Fire safety certificate issued from the competent Govt. Authority.

No reply received and the stipulated time period has already been over.

In view of the above, the Committee decided as under:

Recognition granted to B.Ed. course is **withdrawn** under section 17(1) of NCTE Act, 1993 from the academic session **2020-2021**.

7. **NOW THEREFORE**, recognition granted to the institution viz. **Chanakya Foundation, Vill:- Chhitampur, Street/Road: Chanakya Nagar, Taluka/Mandal: Koilwar, Town/City:Chhitampur, Dist: Bhojpur, Bihar-802160 (Code No. ERCAPP201646142) (ID No.9858)** for B.Ed. course is hereby **withdrawn** under section 17(1) of NCTE Act, 1993 from the academic session **2020-2021**.

8. Further, if the institution is not satisfied with the order, they can prefer an appeal under Section 18 of the NCTE Act in the "Online mode" available at NCTE's website www.ncte-india.org within 60 days from the date of issue of the order.
