**ORDER**

WHEREAS, Bihar College of Education, Plot No- 2110, 2112, 2113, 2116, 2126, Vill- Jadhua Baraitola, Po/Town/City- Hajipur, Tehsil/Taluka- Hajipur, Dist - Vaishali, Bihar- 844101 (B.Ed.) (ERCAPP37/2012) has grant of recognition for B.Ed. course with an intake of 100 from the academic session 2014-2015 vide order dated 03.03.2014, followed by revised order dated 31.05.2015 with an intake of 100 (two basic units) from the academic session 2015-2016 as per NCTE Regulations, 2014 subject to fulfilment of the conditions in respect of enhancement of additional built up area, additional infrastructure, additional fund, additional staff, maintain and update website and to comply the same to the ERC.


2. AND WHEREAS, institution submitted reply dt.29.10.2015 received in this office on 31.10.2015 in compliance of the revised recognition order. The ERC in its 267<sup>th</sup> meeting held on 10<sup>th</sup> – 11<sup>th</sup> February, 2019 considered the matter along with the reply submitted by the institution in compliance to revised recognition order and as per decision of the ERC, Show Cause Notice was issued under section 17(1) of the NCTE Act, 1993 on 26.02.2020 to the institution.

3. AND WHEREAS, the institution has not submitted any reply in response to Show Cause Notice. The ERC in its 279<sup>th</sup> meeting held on 14<sup>th</sup> – 16<sup>th</sup> February, 2020 considered the matter and as per decision of the ERC, Final Show Cause Notice was issued under section 17(1) of the NCTE, Act, 1993 to the institution on 26.02.2020 on the following grounds:-

- i. Approved faculty list (current) by the concerned affiliating body along with requisite documents.
- ii. Approved building plan by the concerned competent Govt. Engineer/Authority.
- iii. Approved building completion certificate by the concerned competent Govt. Engineer/Authority.
- iv. FDRs towards Endowment fund and Reserve fund after conversion into joint operation mode as prescribed in the NCTE Regulations, 2014.
- v. Confirmation on website updates of the institutions with all details along with affidavit.
- vi. Certified copy of registered land document to be submitted.
- vii. Certified copy of Fire Safety Certificate duly signed by the Govt. competent authority to be submitted.

4. AND WHEREAS, the institution has submitted reply dt.16.03.2020 received on 17.03.2020 in response to the Final Show Cause Notice. The ERC in its 283<sup>rd</sup> meeting held on 24<sup>th</sup> & 25<sup>th</sup> August, 2020 considered the original file of the institution along with other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and the following observation was made:-

- i. Original FDRs of Rs. 5 lakh and Rs. 7 lakh has not been submitted.
- ii. Validity of Fire Safety Certificate has been expired on 31.05.2020.


- iii. Requisite information of the institutional website has not updated as per clause 7(14)(i) of NCTE Regulation, 2014.

**“Hence, B.Ed. course is withdrawn under section 17(1) of NCTE Act, 1993 from the next academic session 2021-22.”**

NOW THEREFORE, recognition granted to **Bihar College of Education, Plot No- 2110, 2112, 2113, 2116, 2126, Vill- Jadhua Baraitola, Po/Town/City- Hajipur, Tehsil/Taluka- Hajipur, Dist - Vaishali, Bihar- 844101 (ERCAPP37/2012)** for B.Ed. Course is hereby **withdrawn** in terms of 17(1) of NCTE Act, 1993 with effect from the **academic session 2021-2022**.

6. Further, if the institution is not satisfied by the order, they can prefer an appeal under section 18 of the NCTE Act in the “Online mode” available on NCTE’s website **www.ncte.gov.in** within 60 days from the date of the issue of the order.


