WHEREAS, Forbesganj College, Plot No. Kirkichia, Street No. By pass, Vill./PO.-Forbesganj, Tehsil/Taluka-Forbesganj, Town/City-Forbesganj, Dist.-Araria, Bihar-854318 (ERCAPP404) was granted recognition for B.E.J. course with an intake of 100 from the academic session 2013-2014 vide ERC Order No. 14753 dated 14.11.2012, followed by revised order vide No. 32655 dated 31.05.2015 from the academic session 2015-2016 as per NCTE Regulations, 2014 subject to fulfilment of the conditions in respect of enhancement of additional built up area, additional infrastructure, additional fund, additional staff, maintain and update website and to comply the same to the ERC.

- 2. AND WHEREAS, the ERC in its 265th meeting held on 30th April to 2nd May, considered the matter and as decided, Show Cause Notice U/s 17(1) was issued on 18.01 2019 to the institution on the following grounds:
 - (i) Faculty list comprising 10 instead of 16 as per NCTE Regulations, 2014 and also not in the NCTE prescribed proforma. Required faculties (1+15) qualified as per Norms need to be appointed and approved faculty list in the NCTE prescribed proforma is to be submitted.
 - (ii) Building plan approved by Govt. Engineer is not submitted.
 - (iii) Building Completion certificate is not issued by Govt. Engineer.
- 3. AND WHEREAS, in response to SCN issued to the institution dated 18.05.2019, reply of SCN not received in this office within stipulated time. Matter placed in the 274^{th} ERC meeting held on $15^{th} 16^{th}$ July 2019 and committee decided to withdraw recognition on the above points.
 - > 1st show cause notice u/s 17(1) issued on 20.04.2018. Final show cause notice issued dated 18.01.2019 on the following grounds:
 - a) Faculty list comprising 10 instead of 16 as per NCTE Regulations, 2014 and also not in the NCTE prescribed proforma. Required faculties (1+15) qualified as per Norms need to be appointed and approved faculty list in the NCTE prescribed proforma is to be submitted.
 - b) Building plan approved by Govt. Engineer is not submitted.
 - c) Building completion certificate is not issued by Gov1. Engineer.

No reply received and the stipulated time period has already been over.

Recognition granted to **B.Ed. cours** is withdrawn under section 17(1) of NCTE Act, 1993 from the academic session 2020-2021.
