REVISED ORDER

WHEREAS, in terms of Section 14(1) of the NCTE Act, 1993, Bihar Vidyapeeth, Street/Road - Sadaquat Ashram, Patna, Vill - Patna, Po - Sadaquat Ashram, Tehsil/Taluka - Mainpura, Town/City - Patna, Dist - Patna, Bihar - 800010 has applied for grant of recognition to **Deshratan Rajendra Prasad Shikshan Prashikshan Mahavidyalaya, Plot no - 199,591,596, Street no - Thana No 2, Vill - Mainpura, Po - Sadaquat Ashram, Patna, Tehsil/Taluka - Patna Sadar, Town/City - Patna, Dist - Patna, Bihar - 800010 (Code No.- ERCAPP4072)** for **B.Ed. programme** online on **30.06.2015** for two year duration and hard copy received by Eastern Regional Committee of NCTE on **11.07.2015**.

2. **AND WHEREAS**, as per decision taken by ERC in its 242nd Meeting, recognition granted to the institution for conducting B.Ed. course of two years duration with an intake of 100 (two basic units) from the academic session 2018-2019 vide order No. ER-242.6.16/ERCAPP4072/B.Ed./2017/53997 dated 01.08.2017.

3. **AND WHEREAS**, on scrutiny, it was observed that inadvertently the recognition order issued to this institution for **B.Ed. course with intake of 100 (two basic units) instead of 50 (one basic unit)**.

In view of the above, the Committee decided as under:

A revised recognition order be issued to the institution for one basic unit i.e. **50 intake**, which is to be followed from the academic session **2018-2019**.

4. **NOW THEREFORE**, in exercise of the powers vested under Section 14(3)(a) of the NCTE Act, 1993, the Eastern Regional Committee, NCTE hereby grants recognition to **Deshratan Rajendra Prasad Shikshan Prashikshan Mahavidyalaya, Plot no - 199,591,596, Street no - Thana No 2, Vill - Mainpura, Po - Sadaquat Ashram, Patna, Tehsil/Taluka - Patna Sadar, Town/City - Patna, Dist - Patna, Bihar - 800010** for conducting **B.Ed. programme** of two years duration with an intake of **50 (one basic unit)** from the academic session **2018-2019** under Clause 7(16) of NCTE (Recognition Norms & Procedure) Regulations, 2014 subject to fulfillment of the following conditions:-

- I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Loan raising against or mortgaging of FDRs shall not be done.


- II. The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.
 - III. The institution shall make admission only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations 2014.
 - IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
5. Further, the recognition/permission is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University / Body, the State Government etc, as applicable.
6. The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
7. The institution shall maintain its website with hyperlink to the Council and the Eastern Regional Committee, covering, inter-alia, the details of the institution, its location, name of the programme applied for with intake; availability of physical infrastructure, such as land, building, office, classrooms and other facilities or amenities; instructional facilities, such as laboratory and library and the particulars of their proposed teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website, namely:-
- a) Sanctioned programmes along with annual intake in the institution;
 - b) Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph;
 - c) Name of faculty members who left or joined during the last quarter;
 - d) Names of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;
 - e) Fee charged from students;
 - f) Available infrastructural facilities;
 - g) Facilities added during the last quarter;
 - h) Number of books in the library, journals subscribed to, and additions, if any, in the last quarter;
 - i) The affidavit with enclosure submitted along with application;
 - j) The institution shall be free to post additional relevant information, If it so desires.
 - k) Any false or incomplete information on its website shall render the institution liable for withdrawal of recognition.

8. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.
9. The institution shall make available list of students admitted on its official website.
10. The Educational institution shall follow Uniform Accounting System as brought out by ICAI and accepted by MHRD.
11. If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made and issued there under, the institution will render itself liable to adverse action including withdrawal of recognition / permission by the Regional Committee under the provisions of Section 17(1) of the NCTE Act.
12. The Recognition Order issued earlier vide order No. F.No.ER-242.6.16/ERCAPP4072/B.Ed./2017/53997 dated 01.08.2017 is hereby treated as null and void.
