ORDER

WHEREAS, Lakshmi Narayan College, Bhagwanpur, Plot No.73, Vill-Bhagwanpur, Po-Bhagwanpur, Tehsil/Taluka-Bhagwanpur, Dist-Vaishali, Bihar-844114 (Code No. ERCAPP536) was granted recognition for B.Ed. course with an intake of 100 from the academic session 2012-2013 vide ERC order dated 17.08.2012, followed by revised recognition order dated 29.05.2015 from the academic session 2015-2016 as per NCTE Regulations, 2014 subject to fulfilment of the conditions in respect of enhancement of additional built up area, additional infrastructure, additional fund, additional staff, maintain and update website and to comply the same to the ERC.

- 2. AND WHEREAS, the ERC in its 272^{nd} meeting held on 30^{th} May -01^{st} June, 2019 considered the matter along with reply dated 17.05.2019 (on the basis of proceedings uploaded on ERC website) submitted by the institution in response to Show Cause Notice and decided to withdraw recognition of the institution under section 17(1) of NCTE Act, 1993 from the academic session 2020-2021 on the following grounds:
 - i. Show Cause Notice u/s 17(1) was issued on 14.02.2019 & 21.05.2019.
 - ii. The submitted faculty list is not complete as per NCTE Regulations, 2014 and Gazette Notification No.237 of NCTE published on 09.06.2017.

Accordingly, withdrawal order u/s 17(1) was issued vide order dated 19.06.2019 to the institution.

- 3. AND WHEREAS, the institution preferred an appeal to the NCTE Hqrs. against the ERC's order dated 19.06.2019. The Appellate Authority vide its Order No.89-330/E-132031/2019 Appeal/38th Mtg.-2019/28th November, 2019/86561 dated 23.12.2019 remanded back the case to ERC for revisiting the matter after the appellant submits the required details of faculty approved by affiliating body within 15 days of the issue of appeal order.
- 4. AND WHEREAS, the ERC in its 279th meeting held on 14th 16th February, 2020 considered the original file of the institution along with other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and appeal order dated 23.12.2019 and decided as under:-

Restoration of recognition order of B.Ed. course to be issued.

5. NOW THEREFORE, recognition withdrawn vide order dated 19.06.2019 to the institution viz. Lakshmi Narayan College, Bhagwanpur, Plot No.73, Vill-Bhagwanpur, Po-Bhagwanpur, Tehsil/Taluka-Bhagwanpur, Dist-Vaishali, Bihar-844114 (Code No. ERCAPP536) for B.Ed. course is hereby restored.
