ORDER

WHEREAS, Lakshmi Narayan College, Bhagwanpur, Plot No. 73, Vill/Po- Bhagwanpur, Tehsil/Taluka- Bhagwanpur, Dist.- Vaishali, Bihar- 844114 (Code No.ERCAPP536) was granted recognition for B.Ed. course with an intake of 100 from the academic session 2012-2013 vide ERC Order No. 13305 dated 17.08.2012, followed by revised order vide No.32417 dated 29.05.2015 from the academic session 2015-2016 as per NCTE Regulations, 2014 subject to fulfilment of the conditions in respect of enhancement of additional built up area, additional infrastructure, additional fund, additional staff, maintain and update website and to comply the same to the ERC.

- 2. **AND WHEREAS**, the ERC in its 271^{st} meeting held on 24^{th} 25^{th} April, 2019 considered the matter and as decided, Show Cause Notice u/s 17(1) was issued on 21.05.2019 to the institution on the following grounds:
 - (i) In the submitted faculty list at sl. no.4 & 10, no name of the faculty is mentioned. Besides Ms. Chandana Kumari (Gen), a faculty so appointed as Asst. Professor at sl. No.3 as against Science does not possess required 55% marks in Master's degree, instead she has 53%.
 - (ii) The submitted approved building plan is incomplete and the total built up area does not tally with the built up area mentioned in the building completion certificate.
- 3. **AND WHEREAS**, the ERC in its 272nd Meeting held on 30th May 1st June, 2019 considered the matter along with the reply dated 17.05.2019 submitted by the institution in response to Show Cause Notice and observed as under:
 - (i) Show Cause Notice u/s 17(1) was issued on 14.02.2019 & 21.05.2019.
 - (ii) The submitted faculty list is not complete as per NCTE Regulations, 2014 and Gazette Notification No.237 of NCTE published on 09.06.2017.

In view of the above, the Committee decided as under:

The Committee is of the opinion that recognition granted to **B.Ed. course** of the application bearing Code No. ERCAPP536 is **withdrawn** under section 17(1) of NCTE Act, 1993 from the academic session 2020-2021.

4. NOW THEREFORE, recognition granted to the institution viz. Lakshmi Narayan College, Bhagwanpur, Plot No.-73, Vill.-Bhagwanpur, PO.-Bhagwanpur, Tehsil/Taluka- Bhagwanpur, Dist.- Vaishali, Bihar- 84411 (Code No.ERCAPP536) for B.Ed. Course is hereby withdrawn under section 17(1) of NCTE Act, 1993 with effect from the end of the academic session next following the date of communication of such order i.e. from 2020-2021.
