### **ORDER**

Whereas, the institution Exalt College of Education, Plot No.436-428, Vill-Kanauhali, Po-Kanauhali, Tehsil/Taluka-Garaul, Town/City-Mahua, Dist-Vaishali, Bihar-844101 (B.Ed.) (ERCAPP666) has grant of recognition for conducting B.Ed. course with intake of 100 from the academic session 2014-2015 followed by revised recognition order issued on 27.05.2015 from the academic session 2015-2016.

- 2. AND WHEREAS, in response to the compliance of the revised recognition, institution has not submitted any reply the ERC in its  $254^{th}$  meeting held on  $16^{th} 17^{th}$  April, 2018 considered the matter and as per decision of the Committee a Show Cause Notice was issued to the institution on 20.04.2018 in compliance of the revised recognition order.
- 3. AND WHEREAS, institution submitted its reply dt.30.04.2018 received in this office on 28.05.2018 in response to Show Cause Notice. The ERC in its  $278^{th}$  meeting held on  $16^{th}-18^{th}$  January, 2020, decided Final Show Cause Notice issue to the institution. The Final Show Cause Notice issued on 28.01.2020 on the following grounds:
  - i. Latest original list of teaching faculty duly approved by the affiliating body to be submitted.
  - ii. Certified copy of Fire Safety Certificate duly signed by the Govt. competent Authority to be submitted.
  - iii. Requisite information of the institutional website has not updated as per clause 7(14)(i) of the NCTE Regulation, 2014.
- 4. AND WHEREAS, institution submitted its reply dt.07.02.2020 received in this office on 13.02.2020 in response to the Final Show Cause Notice. The ERC in its 283<sup>rd</sup> meeting held on 24<sup>th</sup> 25<sup>th</sup> August, 2020 considered the original file of the institution along with other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and the following observation was made:
  - i. List of teaching faculty is not in the NCTE prescribed proforma duly approved by the Registrar of the concerned affiliating body.
  - ii. Requisite information of the institutional website has not updated as per clause 7(14)(i) of NCTE Regulation, 2014.

"Hence, B.Ed. course is withdrawn under section 17(1) of NCTE Act, 1993 from the next academic session 2021-22."
