**ORDER**

WHEREAS, Paramount Teachers Training College, Plot No.8 & 17, Vill-Silout, Vimal, Po-Silout, Tehsil/Taluka-Kudhani, City/Dist-Muzaffarpur, Bihar-843119 (Code No. ERCAPP750) was granted recognition for B.Ed. course with an intake of 100 from the academic session 2012-2013 vide ERC order dated 31.08.2012, followed by revised recognition order dated 30.05.2015 from the academic session 2015-2016 as per NCTE Regulations, 2014 subject to fulfilment of the conditions in respect of enhancement of additional built up area, additional infrastructure, additional fund, additional staff, maintain and update website and to comply the same to the ERC.

2. AND WHEREAS, the ERC in its 274<sup>th</sup> meeting held on 15<sup>th</sup> – 16<sup>th</sup> July, 2019, considered the case and decided to withdraw recognition u/s 17(1) of NCTE Act of the institution with effect from the academic session 2020-2021. Accordingly withdrawal order was issued vide order dated 05.08.2019 to the institution.

3. AND WHEREAS, the institution preferred an appeal to the NCTE Hqrs. against the ERC's order dated 19.06.2019. The Appellate Authority vide its Order No.89-334/E-132622/2019 Appeal/30<sup>th</sup> Mtg.-2019/14<sup>th</sup> October, 2019/83397 dated 25.10.2019 remanded back the case to ERC for considering the compliance which is required to be submitted by appellant institution within 15 days of the issue of appeal order.


4. AND WHEREAS, as per decision of the ERC in its 277<sup>th</sup> meeting held on 19<sup>th</sup> – 20<sup>th</sup> December, 2019 Show Cause Notice issued to the institution on 31.12.2019. In response to the Show Cause Notice, institution submitted reply dt.06.01.2020 received on 14.01.2020.

5. AND WHEREAS, the ERC in its 279<sup>th</sup> meeting held on 14<sup>th</sup> – 16<sup>th</sup> February, 2020 considered the original file of the institution along with other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, were carefully considered by ERC and decided as under:-

**Restoration of recognition order of B.Ed. course to be issued.**

5. NOW THEREFORE, recognition withdrawn vide order dated 05.08.2019 to the institution viz. Paramount Teachers Training College, Plot No.8 & 17, Vill-Silout, Vimal, Po-Silout, Tehsil/Taluka-Kudhani, City/Dist-Muzaffarpur, Bihar-843119 (Code No. ERCAPP750) for B.Ed. course is hereby restored.


