- AND WHEREAS, in response to SCN issued to the institution dated 18.05.2019, reply of SCN not received in this office within stipulated time. Matter placed in the 274th ERC meeting held on 15th – 16th July 2019 and committee took decision as under:
 - 1st show cause notice u/s 17(1) issued on 20.04.2018, followed by final show cause notice dated 18.05.2019 on the following grounds:
 - a) Approved faculty list by the concerned affiliating body along with requisite documents.
 - b) Approved competent building plan the concerned by. Engineer/Authority.
 - c) Approved building completion certificate by the concerned competent Govt. Engineer/Authority.
 - d) FDRs towards Endowment fund and Reserve fund after conversion into joint operation mode as prescribed in the NCTE Regulations, 2014.
