ORDER

WHEREAS, Sukhdeo Narayan Lal Bahadur Sitaram Memorial B.Ed. College, Plot No.-4753, Vill.-Mustafapur, PO.-Malti, Tehsil/Taluka-Asthwan, Town/City-Biharsharif, Dist.-Nalanda, Bihar-803107 (ERCAPP844) was granted recognition for B.Ed. course with an intake of 100 from the academic session 2013-2014 vide ERC Order No. 20970 dated 24.09.2013, followed by revised order vide No. 32704 dated 31.05.2015 with an intake of 50 from the academic session 2015-2016 as per NCTE Regulations, 2014 subject to fulfilment of the conditions in respect of enhancement of additional built up area, additional infrastructure, additional fund, additional staff, maintain and update website and to comply the same to the ERC.

- 2. **AND WHEREAS,** the ERC in its 268th meeting held on 24th 25th February, 2019 considered the matter and as decided, Show Cause Notice u/s 17(1) was issued on 11.03.2019 to the institution on the following grounds:
 - (i) Show Cause Notice u/s 17(1) issued on 18.01.2019 on the ground mentioned therein.
 - (ii) Reply dated 03.02.2019 submitted by the institution intimating that selection/approval of faculty is still pending.
 - (iii) The Committee has allowed 21 days.
- 3. **AND WHEREAS**, the matter was placed before the committee in its 274th ERC meeting held on 15th 16th July, 2019 considered the matter along with the reply dtd. 21.02.2019 submitted by the institution in response to the SCN dtd. 11.03.2019 and observed as under:
- > The decision taken by ERC at sl. No. 53, Item no. 272.14.43 of proceedings of 272nd meeting is rectified with following observation:-
 - (i) Three show cause notice u/s 17(1) were issued on 28.11.2018, 18.01.2019 and 11.03.20196.
 - (ii) In the submitted approved faculty list, six faculties at sl. No. 1 to 6 recruited after 09.06.2017 do not possess NET/Ph.D. qualification as per Gazette Notification No. 237 of NCTE published on 09.06.2017.

Recognition granted to **B.Ed. course** of the application bearing Code No. ERCAPP844 is **withdrawn** under section 17(1) of NCTE Act, 1993 from the academic session 2020-2021.

4. NOW THEREFORE, recognition granted to the institution viz. Sukhdeo Narayan Lal Bahadur Sitaram Memorial B.Ed. College, Plot No.- 4753, Vill.-Mustafapur, PO.-Malti, Tehsil/Taluka-Asthwan, Town/City-Biharsharif, Dist.-Nalanda, Bihar-803107 (Code No. ERCAPP844) for B.Ed. Course is hereby withdrawn under section 17(1) of NCTE Act, 1993 from the academic session 2020-2021.
