- 2. AND WHEREAS, the ERC in its 274th meeting held on 15th-16th July, 2019 considered the matter and decided to withdraw recognition order u/s 17(1) of NCTE Act 1993 from the academic session 2020-2021. Accordingly, withdraw order was issued vide order dated 02.09.2019 to the institution.
- 3. AND WHEREAS, the institution being aggrieved and filed CWJC No.16089 of 2019 in the Hon'ble High Court of Patna. The order dated 06.08.2019 passed by the Hon'ble High Court was considered by the ERC in its 279th meeting held on 14th 16th February, 2020 along with the original file of the institution along with other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and decided is as under:-

Restoration of recognition order of B.Ed. course to be issued.

5. NOW THEREFORE, recognition withdrawn vide order dated 05.08.2019 to the institution viz. Sukhdeo Narayan Lal Bahadur Sitaram Memorial B.Ed.
