College, Plot No. 27, Street Number-Main Road, Vill-Shyampur Bairo (Main Bairo), Po- Hansi Kewal, Tehsil/Taluka- Bhagwanpur, Town/City- Bhagwanpur, Dist.-Vaishali, Bihar-844131 was granted recognition for B.Ed. course with an intake of 100 vide ERC order No. ERC/7-138.6.7/NCTE/B.Ed./2012/13256 dated 13.08.2012, followed by revised recognition order from the academic session 2015-2016 with an intake of 100 (two basic units) vide dated 25.05.2015 as per NCTE Regulations, 2014 subject to fulfilment of the conditions in respect of enhancement of additional built up area, additional infrastructure, additional fund, additional staff, maintain and update website and to comply the same to the ERC.

2. AND WHEREAS, the ERC in its 254<sup>th</sup> meeting held on 16<sup>th</sup> -17<sup>th</sup> April, 2018 considered the matter and Show Cause Notice u/s 17(1) was issued on 20.04.2018 to the institution on the following grounds:

- Approved faculty list (current) by the concerned affiliating body along with requisite documents;
- Approved building plan by the concerned competent Govt. Engineer/Authority.
- Approved building completion certificate by the concerned competent Govt. Engineer/Authority.
- FDRs towards Endowment fund and Reserve fund after conversion into joint operation mode as prescribed in the NCTE Regulations, 2014.
- Confirmation on website updates of the institutions with all details along with affidavit.

3. AND WHEREAS, the institution has submitted reply dt. 04.05.2018 in response to show cause notice issued by ERC letter dated 20.04.2018. The ERC in its 263<sup>rd</sup> Meeting held on 15<sup>th</sup> -16<sup>th</sup> November, 2018 considered the matter and decided to issue another show cause notice u/s 17(1) of the NCTE Act. Accordingly Notice was issued to the institution vide letter dt. 28.11.2018 on the following grounds:-

- Building completion certificate is not in the NCTE prescribed format and also not approved by Govt. Engineer. Total land area and built up area not mentioned in the building completion certificate.
- Website not mentioned.
- Building plan is in piecemeal and small font. Consolidated building plan required to be submitted.






