## **ORDER**

WHEREAS, recognition was granted by the Eastern Regional Committee to Govt. Teachers' Training College, Saharsa, Plot No.08, Street-Kachari, Viil./Po-Saharsa, Tehsil/Taluka-Saharsa, Dist-Saharsa, Bihar-852201 (B.Ed.) (ERCAPP925) vide Order dated 28.07.2012 for B.Ed. Course of one year duration with an annual intake of 100 students from the session 2012-2013, followed by revised order dt.20.05.2015 from the academic session 2015-2016 as per NCTE, Regulation, 2014 subject to fulfilment of the conditions in respect of the enhancement of additional built up area, additional infrastructure, additional fund, additional staff, maintain and update website and to comply the same to the ERC.

- 2. AND WHEREAS, institution not submitted any reply/ representation in compliance to the revised recognition order. The ERC in its 267<sup>th</sup> meeting held on 10<sup>th</sup>-11<sup>th</sup> February, 2019 considered the matter along with the available documents of the institution and as per decision of the ERC, Show Cause Notice was issued under section 17(1) of the NCTE Act, 1993 on 21.02.2019 to the institution.
- 3. AND WHEREAS, the institution has submitted reply dt.11.03.2019 received in this office on 18.03.2019 respectively in response to Show Cause Notice. The ERC in its 278<sup>th</sup> meeting held on 16<sup>th</sup>–18<sup>th</sup> January, 2020 considered the matter along with the reply and as per decision of the ERC, Final Show Cause Notice was issued under section 17(1) of the NCTE, Act, 1993 to the institution on 28.01.2020 on the following grounds:
  - i. Teaching faculty mentioned at sl. No.7 to 12 do not possess NET/ Ph.D. qualification as per amendment Gazette Notification dated 09.06.2017. However, only 1+5 are eligible as per list submitted by the institution.
  - ii. Building Plan (BP) is not legible. No data is mentioned including Land area, built up area etc. So legible copy of the Building Plan (BP) duly signed by the competent authority to be submitted.
  - iii. Building Completion Certificate (BCC) duly signed by the competent authority to be submitted.
  - iv. Certified copy of Fire Safety Certificate duly signed by the Govt. competent Authority to be submitted.
  - v. Requisite information of the institutional website has not updated as per clause 7(14)(i) of the NCTE Regulation, 2014.
- 4. AND WHEREAS, the institution has submitted reply dt.15.02.2020 received in this office on 24.02.2020. The ERC in its 283<sup>rd</sup> meeting held on 24<sup>th</sup> & 25<sup>th</sup> August, 2020 considered the original file of the institution along with other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and the following observation was made:
  - i. Original list of teaching faculty duly approved by the concerned affiliating body has not submitted.
  - ii. Blue print of Building Plan (BP) mentioning the details of Plot No./khasra No., total land area, total built up area etc., duly approved by the Govt. Engineer has not submitted.
  - iii. There is a mismatch of floor-wise and total built up area mentioned in Building Plan (BP) and Building Completion Certificate (BCC).

iv. Latest Building Completion Certificate (BCC) duly signed by the competent authority has not submitted.

- vi. Requisite information of the institutional website has not updated as per clause 7(14)(i) of NCTE Regulation, 2014.

"Hence, B.Ed. course is withdrawn under section 17(1) of NCTE Act, 1993 from the next academic session 2021-22."

- NOW THEREFORE, recognition granted to Govt. Teachers' Training College, Saharsa, Plot No.08, Street-Kachari, Viil./Po-Saharsa, Tehsil/Taluka-Saharsa, Dist-Saharsa, Bihar-852201 (B.Ed.) (ERCAPP925) for B.Ed. Course is hereby withdrawn in terms of 17(1) of NCTE Act, 1993 with effect from the academic session 2020-2021.
- Further, if the institution is not satisfied by the order, they can prefer an appeal under section 18 of the NCTE Act in the "Online mode" available on NCTE's website www.ncte.gov.in within 60 days from the date of the issue of the order.
