## **ORDER**

WHEREAS, Tarkeshwar Prasad Varma College, Plot No.6-30, Street No. 01, Vill/Po/City- Narkatiaganj, Tehsil/Taluka-Narkatiaganj, Dist-Paschim Champaran, Bihar-845455 (B.Ed.) (ERCAPP942) was granted recognition for B.Ed. course with an intake of 100 (Two basic Units) from the academic session 2014-2015 vide ERC order No.22328 dated 11.12.2013, followed by revised order vide No.31971 dated 23.05.2015 from the academic session 2015-2016 as per NCTE Regulations, 2014.

- 2. AND WHEREAS, Withdrawal order under section 17(1) of NCTE Act, 1993 was issued vide No.61361 dt.22.08.2019 to the institution withdrawing recognition from the academic session 2020-2021 as per decision of ERC taken in 275<sup>th</sup> meeting held on 27<sup>th</sup> July, 2019 for 1<sup>st</sup> show cause notice u/s 17(1) issued on 14.02.2019, followed by final show cause notice dated 18.06.2019 and the institution was still deficient on the following grounds:
  - i. Building plan and building completion certificate are not approved by competent Govt. Engineer.
  - ii. Two faculties fall short of requirement under NCTE Regulations, 2014 for running 100 intake of B.Ed. course.
- 3. AND WHEREAS, the institution preferred an appeal to the NCTE Hqrs. against the withdrawal order of ERC and the Appellate Authority vide order No.89-413/E-139153/2019 Appeal/8<sup>th</sup> Mtg.-2020/ 27<sup>th</sup> February, 2020/ 91490 dt.15.07.2020 remanded back the case to ERC with a direction to consider the faculty list and the Building Completion Certificate, to be sent to ERC by the appellant, and take further action as per the NCTE Regulations, 2014. The appellant is directed to forward to the ERC the faculty list and Building Completion Certificate within 15 days of receipt of orders on the appeal.
- 4. AND WHEREAS, on the direction of Appellate Authority, institution submitted reply dt.26.02.2020 received through E-mail on 08.03.2020 and hard copy of the same received on 13.03.2020.
- 5. AND WHEREAS, the ERC in its 283<sup>rd</sup> meeting held on 24<sup>th</sup> & 25<sup>th</sup> August, 2020 considered the original file of the institution along with other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and appeal order dated 15.07.2020 and committee decided as under:-

Restoration of recognition order of B.Ed. course to be issued.
