ORDER

WHEREAS, Tarkeshwar Prasad Varma College, Plot No.- 6/30, Street No.- 01, Vill./PO.- Narkatiaganj, Town/CityNarkatiaganj, Tehsil/TalukaNarkatiaganj, Dist.- Paschim Champaran, Bihar- 845455 (Code No. ERCAPP942) was granted recognition for B.Ed. course with an intake of 100 from the academic session 2014-2015 vide ERC Order No. 22328 dated 11.12.2013, followed by revised order vide No.31971 dated 23.05.2015 from the academic session 2015-2016 as per NCTE Regulations, 2014 subject to fulfilment of the conditions in respect of enhancement of additional built up area, additional infrastructure, additional fund, additional staff, maintain and update website and to comply the same to the ERC.

2. **AND WHEREAS**, the ERC in its 272nd meeting held on 30th May – 1st June, 2019 considered the matter and as decided, Show Cause Notice u/s 17(1) was issued on 18.06.2019 to the institution on the following grounds:

- (i) The submitted faculty comprises of 1+13 instead of 1+15 required under NCTE Regulations, 2014.
- (ii) Building completion certificate is not submitted.

3. **AND WHEREAS**, the ERC in its 275th Meeting held on 26th July, 2019 considered the matter and reply dated 11.07.2019 from the institution in response to Show Cause Notice dated 18.06.2019 and observed as under.

- 1 st show cause notice u/s 17(1) issued on 14.02.2019, followed by final show cause notice dated 18.06.2019 and the institution is still deficient on the following grounds:-

- (i) Building plan and building completion certificate are not approved by competent Govt. Engineer.
- (ii) Two faculties fall short of requirement under NCTE Regulations, 2014 for running 100 intake of B.Ed. course.

Recognition granted to B.Ed. course is **withdrawn** under section 17(1) of NCTE Act, 1993 from the academic session 2020-2021.

4. **NOW THEREFORE**, recognition granted to the institution viz. **Tarkeshwar Prasad Varma College, Plot No.- 6/30, Street No.- 01, Vill./PO.- Narkatiaganj, Town/CityNarkatiaganj, Tehsil/TalukaNarkatiaganj, Dist.- Paschim Champaran, Bihar- 845455 (Code No. ERCAPP942)** for **B.Ed. Course** is hereby **withdrawn** under section 17(1) of NCTE Act, 1993 **from the academic session 2020-2021.**
