ORDER

WHEREAS, In terms of Section 14(1) of the NCTE Act, 1993, Directorate of Distance Education, Lalit Narayan Mithila University, Darbhanga, Bihar-846008 (Code No.APE00389) has applied for grant of recognition for B.Ed. (ODL Mode) course was received by Eastern Regional Committee of NCTE on 22.03.2004.

2. AND WHEREAS, the institution was granted recognition for conducting B.Ed.(ODL Mode) Course vide Order No. ERC/7-77.6(II).51/2007/67981 dated 04.07.2007 with 500 intake by the ERC, NCTE.

3. AND WHEREAS, as per decision of 244th ERC Meeting, recognition granted to B.Ed.(ODL Mode) course was withdrawn under section 17(1) of NCTE Act, 1993 from the next academic session vide ERC Order No. ER-244.17.9/APE00389/(B.Ed.-ODL Mode)/2017/54774 dated 23.10.2017.

4. AND WHEREAS, the institution preferred an appeal to NCTE HQs. and the Appellate Authority vide Order No. 89-745/E-49983/ 2017-Appeal/2nd Mtg.-2018/3rd & 5th Feb., 2018/64135 dated 16.03.2018 remanded back the case to ERC to consider the letter sent by appellant to ERC on 05.01.2015 and take a decision accordingly Appellant is required to send a copy of its earlier communication (with enclosures) sent by speed post to ERC on 05.01.2015.

5. AND WHEREAS, the ERC in its 254th meeting held on 16th – 17th April, 2018 re-viewed the matter in accordance with the appeal order and observed that all required documents, as submitted by the institution to the Appellate Authority, have been received.

In view of the above, the Committee decided as under:

Recognition for B.Ed.(ODL Mode) course is continued.

6. NOW THEREFORE, the recognition granted to B.Ed. course issued vide order No. ERC/7-77.6(II).51/ 2007/67981 dated 04.07.2007 is hereby continued.
