ORDER

WHEREAS, in terms of Section 15(1) of the NCTE Act, 1993, Sudhir Educational and Research Foundation, Plot No. 103, Street/Road- Kaushalya Residency, Vill- Tarkeshwar Path Nageshwar Colony, Po- Boring Road, Tehsil/Taluka- Patna, Town/City- Patna, Dist.-Patna, Bihar-800001 has applied for grant of recognition/permission to Balmiki Teachers Training College, Plot No. 28, Vill- Shahjahanpur, Po- Baluka Ram, Tehsil/Taluka- Vaishali, Town/City- Vaishali, Dist.- Vaishali, Bihar-844124 (Code No.- ERCAPP2271) for D.El.Ed. (Addl. Course) online on 18.05.2015 for two years duration and hard copy received by Eastern Regional Committee of NCTE on 21.05.2015.

- 2. WHEREAS, as per the decision taken by ERC in its 207th meeting held on 1st 3rd March, 2016, formal recognition order was issued to Balmiki Teachers Training College, Plot No. 28, Vill- Shahjahanpur, Po- Baluka Ram, Tehsil/Taluka- Vaishali, Town/City-Vaishali, Dist.- Vaishali, Bihar-844124 for conducting D.El.Ed.(Addl. course) of two years duration with an annual intake of 50 (one basic unit) from the academic session 2016-17 under clause 7(16) of the NCTE Regulation 2014, vide ERC order No. ER-207.6.17/ERCAPP2271/D.El.Ed. (Addl. Course)/2016/44329 dated 03.03.2016 followed by corrigendum vide F.No.ER-Corrigendum/ERCAPP2271/D.El.Ed. (Addl. Course)/2016/45788 dated 28.04.2016.
- 3. AND WHEREAS the applicant institution/trust/society filled a writ petition W.P. (C) No. 6170 of 2016 in the Hon'ble High Court of Orissa, Cuttack for a direction to grant permission for the second unit and additional intake of 50 students, till disposal of the writ petition. The Hon'ble High Court of Orissa, Cuttack has disposed of writ petition on 26.04.2016 and with a direction inter alia "In view of the counter affidavit filed by NCTE, the opp. parties have brought to the notice of this court that in I.A No. 9 of 2016 arising out of writ petition (civil) No. (S) 276 of 2012 the Hon'ble Supreme Court on 28.03.2016 has directed that the last date for grant of final recognition as well as affiliation for the session 2016-17 was extended up to 02.05.2016 and 30.05.2016 respectively.

Mr. Das, learned counsel on behalf of the NCTE submits that in view of such extension of time granted by the Hon'ble Supreme Court in the aforesaid case, there is no impediment on the part of the NCTE for granting recognition for the second unit of the petitioner-institution, and earlier rejection of the petitioner representation shall not stand on the way of the NCTE considering/granting necessary recognition for the second unit for which the petitioner had sought for.

In view of the above submission, we direct the opposite parties-NCTE to take a decision within the period as stipulated by the Hon'ble Supreme Court and intimate the petitioner-institution forthwith".

AND WHEREAS the Eastern Regional Committee in its 213th meeting held on 29th 30th April, 2016 & 1st 2nd May, 2016 considered the original file of the institution along with the order of the Hon'ble High Court of Orissa, Cuttack dated 26.04.2016 and decided that, formal revised recognition order under clause 7(16) of the NCTE Regulation 2014 for applied D.El.Ed. programme with an intake 100(two basic units) from the academic session 2016-17 be issued to the institution.
- NOW THEREFORE, in exercise of the powers vested under Section 15(3)(a) of the 5. NCTE Act. 1993, the Eastern Regional Committee, NCTE hereby grants recognition/permission to Balmiki Teachers Training College, Plot No. 28, Vill-Shahjahanpur, Po- Baluka Ram, Tehsil/Taluka- Vaishali, Town/City- Vaishali, Dist.-Vaishali, Bihar-844124 for conducting D.El.Ed. programme of two years duration with an intake of 100 (two basic units) from the academic session 2016-2017 under Clause 7(16) of NCTE (Recognition Norms & Procedure) Regulations, 2014 subject to fulfillment of the following conditions:-
 - The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Loan raising against or mortgaging of FDRs shall not be done.
 - II. The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.
 - III. The institution shall make admission only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations 2014.
 - IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
- 6. The recognition/permission is subject to the condition that the institution shall move gradually to become a composite institution but not later than 2016-2017.
- 7. Further, the recognition/permission is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University / Body, the State Government etc, as applicable.
- 8. The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- 9. The institution shall maintain its website with hyperlink to the Council and the Eastern Regional Committee, covering, inter-alia, the details of the institution, its location, name of the programme applied for with intake; availability of physical infrastructure, such as land, building, office, classrooms and other facilities or amenities; instructional facilities, such as laboratory and library and the particulars of their proposed teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website, namely:-

- a) Sanctioned programmes along with annual intake in the institution;
- b) Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph;
- c) Name of faculty members who left or joined during the last quarter;
- d) Names of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;
- e) Fee charged from students;
- f) Available infrastructural facilities;
- g) Facilities added during the last quarter;
- h) Number of books in the library, journals subscribed to, and additions, if any, in the last quarter;
- i) The affidavit with enclosure submitted along with application;
- j) The institution shall be free to post additional relevant information, If it so desires.
- k) Any false or incomplete information on its website shall render the institution liable for withdrawal of recognition.
- 10. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.
- 11. The institution shall make available list of students admitted on its official website.
- 12. If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made and issued there under, the institution will render itself liable to adverse action including withdrawal of recognition / permission by the Regional Committee under the provisions of Section 17(1) of the NCTE Act.
