ORDER

WHEREAS, Kamla Bhubaneswar B.Ed. College, Plot No.-1410, 1411, 1412, Vill./P.O. - Chandour, Tehsil/Taluka- Bhagwanpur, Town/City-Teghra, Dist.- Begusarai, Bihar - 851133 was granted recognition for B.Ed. course with an intake of 100 vide ERC order No. ERC/7-169.6.7/NCTE/B.Ed./2014/24275 dated 25.02.2014, followed by revised recognition order from the academic session 2015-2016 with an intake of 100 (two basic units) vide dated 23.05.2015 as per NCTE Regulations, 2014 subject to fulfilment of the conditions in respect of enhancement of additional built up area, additional infrastructure, additional fund, additional staff, maintain and update website and to comply the same to the ERC.

- 2. AND WHEREAS, the ERC in its 254th meeting held on 16th -17th April, 2018 considered the matter and Show Cause Notice u/s 17(1) was issued on 20.04.2018 to the institution on the following grounds:
 - Approved faculty list (current) by the concerned affiliating body along with requisite documents.
 - b. Approved building plan by the concerned competent Govt. Engineer/Authority.
 - c. Approved building completion certificate by the concerned competent Govt. Engineer/Authority.
 - d. FDRs towards Endowment fund and Reserve fund after conversion into joint operation mode as prescribed in the NCTE Regulations, 2014.
 - e. Confirmation on website updates of the institutions with all details along with affidavit.
- 3. AND WHEREAS, the institution had submitted reply dt. 05.05.2018 in response to show cause notice received on 08.05.2018. The ERC in its 263rd Meeting held on 15th -16th November, 2018 considered the matter and decided to issue another show cause notice u/s 17(1) of the NCTE Act, 1993 to the institution. Accordingly, show cause notice u/s 17(1) was issued on 28.11.2018 to the institution on the following grounds:-
 - (i) Faculty list submitted is not approved by Registrar of the concerned affiliating body.
 - (ii) Building plan submitted is in piecemeal and small font. The institution is required to submit legible copy of building plan duly approved by Govt. Engineer.
 - (iii) Building completion certificate submitted is not approved by Govt. Engineer.
 - (iv) Photocopy of submitted FDRs are not clearly visible.
- 4. AND WHEREAS, the institution had submitted reply dated 13.12:2018 & 29.11.2019 received in this office on 05.12.2019. The ERC in its 278th meeting held on 16th -18th January, 2020 after considering the original file of the institution along with other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and following observation was made:

- (ii) Total built up area mentioned in the Building Plan (BP) as well as Building Completion Certificate (BCC) is of 3032.52 Sq. Mts., which is less than required 4000 Sq. Mts. to run 02 units of B.Ed. and 02 units of D.El.Ed. course.
- (iii) It is not clear from the photocopy of FDRs that the institution is maintaining FDRs Rs.5 lakh and Rs.3 lakh jointly with NCTE as per Regulation, 2014.

Hence, B.Ed. course is withdrawn under section 17(1) of NCTE Act, 1993 from the next academic session 2020-21.

- 5. NOW THEREFORE, recognition granted to the institution viz. Kamla Bhubaneswar B.Ed. College, Plot No.-1410, 1411, 1412, Vill./P.O. Chandour, Tehsil/Taluka- Bhagwanpur, Town/City-Teghra, Dist.- Begusarai, Bihar-851133 (ERCAPP17/2012) for B.Ed. Course is hereby withdrawn under section 17(1) of NCTE.Act, 1993 from the next academic session 2020-2021.
- 6. **FURTHER,** if the institution is not satisfied by the order, they can prefer an appeal Under Section 18 of the NCTE Act in the "Online mode" available on NCTE's website <u>www.ncte-india.org</u> within 60 days from the date of the issue of the order.
