In terms of Section 14(1) of the NCTE Act, 1993 Department of Education, Patna University, Daryapur, Baripath, Bankipur, Patna, Bihar - 800004 had submitted an application to the Eastern Regional Committee of NCTE for grant of recognition for M.Ed. course of one year duration.

- 2. On scrutiny of the application submitted by the institution, the documents attached therewith, the inputs received from the visiting team alongwith, other related documents, the Committee has noted the following:
 - i. The institution has acquired the land for setting up the teacher education institution.
 - ii. The institution is functioning from its own building.
 - iii. The institution has selected the Professor in-charge and 04 (four) faculty members and the list of teaching staff has been duly approved by the affiliating university.
- 3. Now, therefore, in exercise of the powers vested under Section 14(3) (a) of the NCTE Act, 1993, the Regional Committee hereby grants recognition to **Department of Education**, **Patna University**, **Daryapur**, **Baripath**, **Bankipur**, **Patna**, **Bihar** 800004 for **M.Ed.** Course of one year duration from the academic session 2006-2007 with an annual intake of 25 (Twenty Five) students subject to compliance of the following conditions before the commencement of the course:
 - a. The institution will ensure that Principal/Head in the rank of Professor/or Reader, and 3 (Three) Readers/ Lecturers as faculty members duly qualified as per NCTE norms are in position for an intake of 25 students before the commencement of the course and a report to this effect shall be sent to the Eastern Regional Committee within one month of the commencement of the course.
 - b. The institution shall submit a list of teaching staff duly countersigned by the competent authority of the affiliating University within one month of the commencement of the course.
 - c. The institution shall pay salary to the teaching staff as prescribed by State Govt./ UGC

- d. The institution shall ensure that lecturers not having M.Ed. should acquire M.Ed. qualification within five years.
- e. The institution shall adhere to all the other regulations and guidelines as framed by NCTE from time to time.
- 4. Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC, the State Government etc.
- 5. The institution shall submit to the Regional Committee a Performance Appraisal Report at the end of each academic year along with a copy of the approval of the affiliating university to the appointment of faculty members, and the statement of annual accounts duly audited by a Chartered Accountant.
- 6. If the institution contravenes any of the above conditions or any of the provisions of the NCTE Act, Rules, Regulations and Orders made or issued there under, the Regional Committee may withdraw the recognition under the provisions of Section 17(1) of the NCTE Act.
