ORDER

WHEREAS, Govt. Teachers Training College, Ranchi, Jharkhand - 834001 (JH-S/N-6/2001) was granted recognition for B.Ed. course with an intake of 100 from the academic session 2002-2003 vide ERC Order No. 1844 dated 20.06.2002, followed by revised order vide No.32743 dated 31.05.2015 from the academic session 2015-2016 as per NCTE Regulations, 2014 subject to fulfilment of the conditions in respect of enhancement of additional built up area, additional infrastructure, additional fund, additional staff, maintain and update website and to comply the same to the ERC.

2. **AND WHEREAS**, the ERC in its 267th Meeting held on 10th - 11th February, 2019 considered the matter and Show Cause Notice u/s 17(1) was issued on 21.02.2019 to the institution on the following grounds:-

- Approved faculty list (current) by the concerned affiliating body along with requisite documents.
- Approved building plan by the concerned competent Govt. Engineer/Authority.
- Approved building completion certificate by the concerned competent Govt. Engineer/Authority.
- FDRs towards Endowment fund and Reserve fund after conversion into joint operation mode as prescribed in the NCTE Regulations, 2014.
- Confirmation on website updates of the institutions with all details along with affidavit.

3. **AND WHEREAS**, the institution had failed to submit reply in response to SCN dated 21.02.2019 within the stipulated time. The ERC in its 271st meeting held on 24th - 25th April, 2019 considered the matter and final show cause Notice u/s 17(1) was issued on 18.05.2019 to the institution to comply the deficiencies mentioned in the SCN dated 21.02.2019.

4. **AND WHEREAS**, the institution had failed to submit reply in response to final SCN dated 18.05.2019 within the stipulated time. The ERC in its 275th meeting (Part-1) held on 26th July, 2019 considered the matter in detail and observed as under:

- Approved faculty list by the concerned affiliating body along with requisite documents.
- Approved building plan by the concerned competent Govt. Engineer/Authority.
- Approved building completion certificate by the concerned competent Govt. Engineer/Authority.
- FDRs towards Endowment fund and Reserve fund after conversion into joint operation mode as prescribed in the NCTE Regulations, 2014.
- Confirmation on website updates of the institutions with all details along with affidavit.

No reply received and the stipulated time period has already been over.

Recognition granted to B.Ed. course is **withdrawn** under section 17(1) of NCTE Act, 1993 from the academic session **2020-2021**.
