Order

In terms of Section 14(1) of the NCTE Act, 1993 Jawaharlal Nehru College, Chakradharpur, West Singhbhum, Jharkhand had submitted an application to the Eastern Regional Committee of NCTE for grant of recognition for starting B.Ed. Course of one year duration from the academic session 2004-2005 with an annual intake of 100 (one hundred) students.

2. On scrutiny of the application submitted by the institution, the documents attached therewith, the inputs received from the visiting team, the Committee has noted the following:

- i. The institution has acquired the land for setting up the teacher education institution.
- ii. At present the institution will function from the existing buildings of the college.
- iii. The institution has not made appointment of Principal/ Head and teaching staff on full time and regular basis.

3. Now, therefore, in exercise of the powers vested under Section 14(3) (a) of the NCTE Act, 1993, the Regional Committee hereby grants recognition to **Jawaharlal Nehru College, Chakradharpur, West Singhbhum, Jharkhand for B.Ed. Course of one year duration from the academic session 2005-2006 with an annual intake of 100 (one hundred) students** subject to fulfillment of the following conditions:

- a. That the institution shall ensure that one HOD and seven teaching faculty members duly qualified as per NCTE norms are in position before the commencement of the B.Ed. course and a report to this effect shall be sent to the ERC within one month from the commencement of the academic session
- b. The institution shall ensure that all teachers are appointed on full time and regular basis.
- c. The institution shall submit a list of teachers duly counter signed by the competent authority of the affiliating University within one month from the commencement of the course.
- d. The institution shall ensure that all the teachers and other staff are paid salary as per UGC/State Govt. pay scale and the acquaintance roll should be sent to ERC, NCTE within three months from the commencement of the course.
- e. The institution shall, within one month of the receipt of recognition order, convert the endowment fund account into a joint account to be operated along with an official of the Eastern Regional Committee.
- f. The institution shall shift to its own premises within three years from the date of recognition
- g. The institution will create reserve fund equivalent to three month salary of the staff and a confirmation to this effect be sent to this office.
- h. The institution shall comply with the various other norms and standards prescribed in the NCTE regulations.

4. Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC, the State Government etc.
5. The institution shall submit to the Regional Committee a Performance Appraisal Report at the end of each academic year along with a copy of the approval of the affiliating University to the appointment of faculty members, and the statement of annual accounts duly audited by a Chartered Accountant.
6. If the institution contravenes any of the above conditions or any of the provisions of the NCTE Act, Rules, Regulations and Orders made or issued thereunder, the Regional Committee may withdraw the recognition under the provisions of Section 17(1) of the NCTE Act.
