ORDER

WHEREAS, A. S. College, Deoghar, PO/Dist - Deoghar, Jharkhand - 814112 (Code No.APE00439) was granted recognition by ERC, NCTE on 12.08.2005 for conducting B.Ed. Course of one year duration with an annual intake of 100 from the academic session 2006-2007 subject to fulfillment of some conditions mentioned therein.

- AND WHEREAS a Public Interest Litigation vide W.P.(PIL) No.327 of, 2011 filed by Shiv Shankar Munda -Vs- Chairperson NCTE & Ors in the Hon'ble High Court of Jharkhand at Ranchi. As per direction of the Hon'ble High Court of Jharkhand, the said institution was inspected by the NCTE Hars., New Delhi under section 13 of the NCTE Act 1993. Accordingly, the NCTE Hars. issued a deficiency letter to the institution along with the report of the Prof. Arora Committee for greater clarity of the deficiencies vide No.93-56/2014/NCTE/Insp./A86657 dated 01.05.2014 on reasons mentioned therein.
 - AND WHEREAS after considering the matter in various meetings, the ERC in its 175th meeting held on 09.09.2014 considered the facts on records available in the file, the inspection report of the NCTE Hars, as well as reply submitted by the institution dated 29.08.2014 in response to ERC's show cause notice U/S 17(1) dated 14.08.2014 and as decided by ERC, withdrawn order was issued to the institution vide No.27322 dated 22.09.2014 from the academic session 2015-2016 in terms of Section 17(1) of NCTE Act 1993 on the following grounds.
 - The institution has not appointed regular HOD/Principal till date.
 - The institution has not appointed teaching faculty and other supporting staff on (ii)
 - The institution has only built up area 5200 Sq. ft. which is less than the required 1500 (iii)
 - Multipurpose hall and Art & Craft Resource Center are not available. (iv)
 - AND WHEREAS the institution preferred an appeal to the NCTE Hars, against the ERC's order dated 22.09.2014. The Appellate Authority vides order No.89-354/2014-Appeal/2nd Meeting-2015/3809 dt.05.05.2015 remanded back the case to ERC with a direction to consider the developments reported by the appellant by conducting an inspection of the institution and take further action as per the NCTE Regulations, 2014, which have come into force w.e.f. 28.11.2014. In the meantime, the order of withdrawal shall be kept in abeyance.

AND WHEREAS the ERC in its 188th meeting held on 19-20 May 2015 considered the appeal order dated 05.05.2015 along with original file of the institution and as decided by the ERC, a letter was issued to the institution dated 24.05.2015 and thereafter receiving the reply from the institution dated 06.06.2015, inspection letter to the institution was issued on 07.07.2015.
- 6. AND WHEREAS the ERC in its 191st meeting held on 14-15 July 2015 considered the letter dated 26.05.2015 from the Director of Higher Education, Government of Jharkhand committed that all such requirements along with appointment of full time faculty will be complied with as per new Regulation 2014 by 31.10.2015, wherein the ERC has decided as under:
 - (i) Recognition of the institution be continued.
 - (ii) Review the status will be taken up after 31st Oct.2015. Deficiency found if any, will be communicated to the institution, concerned University and State Government for compliance.
 - (iii) If the institution fails to comply the deficiencies, further course of action shall be taken as per norms.
- 7. NOW THEREFORE, the recognition of the institution viz. A. S. College, Deoghar, PO/Dist Deoghar, Jharkhand 814112 (Code No.APE00439).
