Order

In terms of Section 14(1) of the NCTE Act, 1993 A.S.College, Deoghar, Pin – 814 112, Jharkhand had submitted an application to the Eastern Regional Committee of NCTE for grant of recognition for starting B.Ed. course of one year duration from the academic session 2004-2005 with an annual intake of 100 (one hundred) students.

- 2. On scrutiny of the application submitted by the institution, the documents attached therewith, the inputs received from the visiting team; the Committee has noted the following:
 - i. The institution proposes to function from its own building
 - ii. The institution building is shared for running another course(s).
 - iii. The institution has selected 07 (seven) faculty members on contract basis with consolidated salary of Rs.8000/- for the said course but the Principal/ HOD has not been identified in the list of teaching staff and the list of teaching staff have been duly approved by the affiliating University.
- 3. Now, therefore, in exercise of the powers vested under Section 14(3) (a) of the NCTE Act, 1993, the Regional Committee hereby grants recognition to **A.S.College, Deoghar, Pin 814 112, Jharkhand** for **B.Ed.** Course of one year duration from the academic session 2006-2007 with an annual intake of 100 (one hundred) students subject to the compliance of the following conditions before the commencement of the course:
 - a) The institution will ensure that Principal/Head and at least 07 (seven) faculty members duly qualified as per NCTE norms are in position for an intake of 100 students before the commencement of the course and a report to this effect shall be sent the Eastern Regional Committee within one month of the commencement of the course.
 - b) The institution shall submit a list of teaching staff duly countersigned by the competent authority of the University within one month of the commencement of the course.
 - c) The institution shall pay salary to the teaching staff as prescribed by State Govt./ UGC.
 - d) The institution shall within one month of the receipt of recognition order, convert the Endowment Fund account into a Joint Account in the form of FDR for a period of not less than 60 months (five years) in a Nationalised Bank to be operated along with an official of the Regional Committee.
 - e) The institution shall create a Reserve Fund for an amount equal to three months salary of the teachers and staff within one month from the date of issue of this order and maintain in the form of FDR in favour of the management of the institution for a period of not less than sixty months (five years) in a Nationalised Bank.
 - f) The institution shall adhere to all the other regulations and guidelines as framed by NCTE from time to time.

- **4.** Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC, the State Government etc.
- **5.** The institution shall submit to the Regional Committee a Performance Appraisal Report at the end of each academic year along with a copy of the approval of the affiliating university to the appointment of faculty members, and the statement of annual accounts duly audited by a Chartered Accountant.
- **6.** If the institution contravenes any of the above conditions or any of the provisions of the NCTE Act, Rules, Regulations and Orders made or issued thereunder, the Regional Committee may withdraw the recognition under the provisions of Section 17(1) of the NCTE Act.
