**Order**

WHEREAS A.S. College, Deoghar, Jharkhand-814112 (Code No. APE00439) was granted recognition by ERC, NCTE on 12.08.2005 for conducting B.Ed. course of one year duration with an annual intake of 100 from the academic session 2006-2007 subject to fulfilment of the following conditions:

- (i) The institution will ensure that Principal/Head and at least 07 (seven) faculty members duly qualified as per NCTE norms are in position for an intake of 100 students before the commencement of the course and a report to this effect shall be sent the Eastern Regional Committee within one month of the commencement of the course.
- (ii) The institution shall submit a list of teaching staff duly countersigned by the competent authority of the University within one month of the commencement of the course.
- (iii) The institution shall pay salary to the teaching staff as prescribed by State Govt./UGC.
- (iv) The institution shall within one month of the receipt of recognition order, convert the endowment fund account into a joint account in the form of FDR for a period of not less than 60 months (five years) in a Nationalized Bank to be operated along with an official of the Regional Committee.
- (v) The institution shall create a Reserve fund for an amount equal to three months salary of the teachers and staff within one month from the date of issue of this order and maintain in the form of FDR in favour of the management of the institution for a period of not less than sixty months (five years) in a Nationalized Bank.
- (vi) The institution shall adhere to all the other regulations and guidelines as framed by NCTE from time to time.

2. AND WHEREAS a Public Interest Litigation vide W.P. (PIL) No. 327 of 2011 has been filed by Shiv Shankar Munda - Vs - Chairperson NCTE & Ors in the Hon'ble High Court of Jharkhand at Ranchi. As per direction of the Hon'ble High Court of Jharkhand, the said institution was inspected by the NCTE Hqs., New Delhi under section 13 of the NCTE Act 1993. Accordingly, the NCTE Hqs. issued a deficiency letter to the institution along with the report of the Prof. Arora Committee for greater clarity of the deficiencies vide No. 93-56/2014/NCTE/Insp./A86657 dated 01.05.2014 with the following observations:-

- (i) The institution is deficient in respect of both infrastructural and instructional facilities.
- (ii) Regarding engagement of staff, the institution has violated the prescribed Norms and conditions of recognition by not appointing a regular HOD, by appointing only five lecturers against the requirement of seven lecturers and by appointing the staff on contractual basis every year for a limited period of 11 months only.

- (iii) The institution also violated the condition in the recognition order by not converting the FDRs in respect of Endowment fund and Reserve fund into joint accounts to be operated jointly with the Regional Director, ERC, Bhubaneswar

3. AND WHEREAS the applicant institution had submitted its representation dated 21.05.2014 in response to deficiency letter dated 01.05.2014 to ERC, NCTE. The Eastern Regional Committee in its 171<sup>st</sup> Meeting held on 3<sup>rd</sup> -4<sup>th</sup> June 2014 considered the representation of the institution and found that non of the deficiencies are complied by the institution. As decided by ERC, Show Cause Notice u/s 17(1) was issued vide No. 26292 dated 18.06.2014 to the institution on the following grounds:-

- (i) Principal/HOD has not been appointed.
- (ii) Appointed teachers are on contractual basis which is against the norms.
- (iii) The built up area is only 5200 Sq. ft. which is less than required 1500 Sq. Mts. (16146 Sq. ft.).
- (iv) Multipurpose hall and Art & Craft Resource Center are not available.
- (v) Original FDRs of Rs. 5.00 lakh and Rs. 3.00 lakh is not submitted towards endowment fund and reserve fund respectively into joint account in the name of institution and RD, ERC, NCTE, Bhubaneswar.

4. AND WHEREAS the applicant institution had submitted its representation dated 08.07.2014 in response to show cause notice u/s 17(1) dated 18.06.2014 to ERC, NCTE. The Eastern Regional Committee in its 174<sup>th</sup> Meeting held on 5<sup>th</sup> August 2014 considered the representation of the institution and found that non of the deficiencies are complied by the institution. As decided by ERC, 2<sup>nd</sup> Show Cause Notice u/s. 17(1) was issued vide No. 26930 dated 14.08.2014 to the institution on the following grounds:-

- (i) The institution has not appointed regular HOD/Principal till date.
- (ii) The institution has not appointed teaching faculty and other supporting staff on regular basis till date as per norms of NCTE.
- (iii) The institution has only built up area 5200 Sq. ft. which is less than the required 1500 Sq. Mts.
- (iv) Multipurpose hall and Art & Craft Resource Center are not available.

5. AND WHEREAS the applicant institution submitted its representation dated 29.08.2014 in response to show cause notice u/s 17(1) dated 14.08.2014 to ERC, NCTE. The Eastern Regional Committee in its 175<sup>th</sup> Meeting held on 9<sup>th</sup> September 2014 considered the facts on records available in the file, the inspection report of the NCTE Hqrs. as well as the reply submitted by the institution. The matter was discussed in detail and observed that the institution is still having the following deficiencies which are contravened to the Norms and Standards prescribed in the Regulations of NCTE:-

- (i) The institution has not appointed regular HOD/Principal till date.
- (ii) The institution has not appointed teaching faculty and other supporting staff on regular basis till date as per norms of NCTE.



- (iii) The institution has only built up area 5200 Sq. ft. which is less than the required 1500 Sq. Mts.
- (iv) Multipurpose hall and Art & Craft Resource Center are not available.

In view of the above, the committee decided as under:

The Committee concluded that the institution is running the B.Ed. course violating the NCTE Norms and Regulation 2009. The Committee, therefore, decided to withdraw the recognition of the institution for B.Ed. course under Section 17(1) of the NCTE Act, 1993 from the academic session 2015-2016.

6. **NOW, THEREFORE, grant of recognition to A.S. College, Deoghar, Jharkhand-814112 (Code No. APE00439) for B.Ed. course is hereby withdrawn from the academic session 2015-2016 in terms of section 17(1) of NCTE Act, 1993.**

7. Further, if the institution is not satisfied with the order, they may prefer an appeal under Section 18 of the NCTE Act in the "Online mode" available at NCTE's website [www.ncte-india.org](http://www.ncte-india.org) within 60 days of the issue of the order.
