**ORDER**

WHEREAS, S.S.L.N.T. Mahila Mahavidyalaya, Buby Circular Road, Hirapur, Dhanbad, Jharkhand - 826001 (Code No. APE00443) was granted recognition by ERC, NCTE on 15.02.2006 for conducting B.Ed. Course of one year duration with an annual intake of 100 from the academic session 2006-2007 subject to fulfillment of some conditions mentioned therein.

2. AND WHEREAS a Public Interest Litigation vide W.P.(PIL) No.327 of 2011 filed by Shiv Shankar Munda -Vs- Chairperson NCTE & Ors in the Hon'ble High Court of Jharkhand at Ranchi. As per direction of the Hon'ble High Court of Jharkhand, the said institution was inspected by the NCTE Hqrs., New Delhi under section 13 of the NCTE Act 1993. Accordingly, the NCTE Hqrs. issued a deficiency letter to the institution along with the report of the Prof. Arora Committee for greater clarity of the deficiencies vide No. 93-62/2014/NCTE/Insp./A86383 dated 30.04.2014 on reasons mentioned therein.

3. AND WHEREAS after considering the matter in various meetings, the ERC in its 175<sup>th</sup> meeting held on 09.09.2014 considered the facts on records available in the file, the inspection report of the NCTE Hqrs. as well as reply submitted by the institution dated 31.08.2014 in response to ERC's show cause notice U/S 17(1) dated 18.08.2014 and as decided by ERC, withdrawn order was issued to the institution vide No.27294 dated 19.09.2014 from the academic session 2015-2016 in terms of Section 17(1) of NCTE Act 1993 on the following grounds.

- (i) The land and building is not demarcated for the B.Ed. programme. Multipurpose hall is not available in the institution. There are no Psychology lab, Language learning lab. Art & work experience room, play-ground, staff room, Principal room and common room for B.Ed. course. The new building is under construction and present building is not as per NCTE norms.
- (ii) Books in the library are only 1006 which is less than the required 3000 books. Seating arrangement in the library is not available. The institution has not submitted any bills/cash memos for purchasing of books in the Library.
- (iii) The institution has not appointed Principal/HOD and other faculty members as well as supporting staff on regular basis as per requirement of NCTE norms.

4. AND WHEREAS the institution preferred an appeal to the NCTE Hqrs. against the ERC's order dated 19.09.2014. The Appellate Authority vide order No.89-357/2014-Appeal/2<sup>nd</sup> Meeting-2015/3849 dt.05.05.2015 remanded back the case to ERC with a direction to revisit the matter in light of the NCTE Regulations 2014 notified in November, 2014.

5. AND WHEREAS the ERC in its 188<sup>th</sup> meeting held on 19-20 May 2015 considered the appeal order dated 05.05.2015 along with original file of the institution and as decided by the ERC, a letter was issued to the institution dated 27.05.2015.

6. AND WHEREAS the ERC in its 191<sup>st</sup> meeting held on 14-15 July 2015 considered the letter dated 26.05.2015 received from the Director of Higher Education, Government of Jharkhand committed that all such requirements along with appointment of full time faculty will be complied with as per new Regulation 2014 by 31.10.2015, wherein the ERC has decided as under:

- (i) Recognition of the institution be continued.
- (ii) Review the status will be taken up after 31<sup>st</sup> Oct.2015. Deficiency found if any, will be communicated to the institution, concerned University and State Government for compliance.
- (iii) If the institution fails to comply the deficiencies, further course of action shall be taken as per norms.

7. NOW THEREFORE, the recognition of the institution viz. **S.S.L.N.T. Mahila Mahavidyalaya, Buby Circular Road, Hirapur, Dhanbad, Jharkhand - 826001 (Code No.APE00443)** for B.Ed. Course is allowed to continue.
