**Order**

WHEREAS B. N. Saha DAV Teacher's Training College, At – Sirsia, Near Giridih Block, Giridih – Madhupur Road, Dist – Giridih, Jharkhand - 815301 (Code No. APE00581) was granted recognition by ERC, NCTE on 10.12.2008 for conducting B.Ed. course of one year duration with an annual intake of 100 subject to fulfilment of the following conditions:

- (i) The institution shall, within one month of the receipt of recognition order, convert the endowment fund account into a joint account to be operated along with an official of the Eastern Regional Committee.
- (ii) The admission of students shall be done only after affiliating by the examining body before the commencement of academic year and the admission of students shall be completed well before the cut-off date prescribed by the examining body for the academic year 2008-2009 failing which the recognition will be deemed to be for the next academic year i.e. 2009-2010.
- (iii) The letter of intent i.e. letter for conditional recognition under Regulations 7(9) of NCTE (Recognition Norms & Procedure) Regulations, 2007 would be subject to the condition that the institution shall not have any right for recognition pertaining to any particular academic year and the discretion is left with NCTE.
- (iv) Formal order for recognition/permission will operate for 2008-2009 only if the requirement of 180 teaching days in the session would be fulfilled as per calendar of the University /Affiliating body.
- (v) The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, as amended from time to time.

2. AND WHEREAS a Public Interest Litigation vide W.P. (PIL) No. 327 of 2011 has been filed by Shiv Shankar Munda - Vs - Chairperson NCTE & Ors in the Hon'ble High Court of Jharkhand at Ranchi. As per direction of the Hon'ble High Court of Jharkhand, the said institution was inspected by the NCTE Hqs., New Delhi under section 13 of the NCTE Act 1993. Accordingly, the NCTE Hqs. issued a deficiency letter to the institution along with the report of the Prof. Arora Committee for greater clarity of the deficiencies vide letter dated 29.04.2014 with the following observations:-

- (i) The institution fulfills the norms regarding land, built up area and infrastructural facilities except the size of multipurpose hall.
- (ii) The institution fulfills the norms regarding instructional facilities.
- (iii) The institution has not maintained endowment and reserve fund in joint accounts with Regional Director, ERC.
- (iv) The institution adhered to the norms regarding engagement of staff except the payment of salary in regular pay scales.
- (v) The instructional management in the institution is fairly satisfactory.

3. AND WHEREAS the applicant institution had not submitted any representation in response to deficiency letter dated 29.04.2014 within the stipulated period to ERC, NCTE. The Eastern Regional Committee in its 172<sup>nd</sup> Meeting held on 17<sup>th</sup> June 2014 considered the matter and found that non of the deficiencies are complied by the institution. As decided by ERC, Show Cause Notice u/s 17(1) to the institution was issued vide No. 26511 dt. 25.06.2014 for compliance of the above deficiencies pointed out by NCTE Hqrs.

4. AND WHEREAS the Eastern Regional Committee in its 173<sup>rd</sup> meeting held on 26<sup>th</sup> June 2014 considered that the complaint dated 12.03.2014 regarding non availability of land and building in the name of the institution and also running a public school in the same campus. As decided by ERC, letter to the office of District Magistrate, Giridih, Jharkhand as well as Registrar, Vinoba Bhave University, Jharkhand were issued on 03.07.2014 with a request to inquiry the matter.

5. AND WHEREAS the applicant institution had submitted its representation dated 26.07.2014 in response to SCN dated 25.06.2014 to ERC, NCTE. The Eastern Regional Committee in its 174<sup>th</sup> Meeting held on 5<sup>th</sup> August 2014 considered the representation of the institution and found that non of the deficiencies are complied by the institution. As decided by ERC, Show Cause Notice u/s 17(1) to the institution was issued vide No. 26984 dated 18.08.2014 on the following grounds:-

- (i) The process to increase the multipurpose hall is in under construction.
- (ii) As per NCTE norms, the academic staff of the institution( including part time staff) shall be paid such salary in such scale of pay as may be prescribed by the UGC/University from time to time, through account payee cheque or as per advice as per advice into the bank account of employee specifically opened for the purpose. The supporting staff shall be paid as per the UGC/State Government/Central Government pay scale structure.
- (iii) The institution is required to submit the 3 months Bank statement clearly stating that amount has been deposited in the bank account of the staff.

6. AND WHEREAS the NCTE Hqrs. forwarded various complaints against the institution vide letter No. A67850, A71260, A74762, A76154, A77441 & A83306 dated 28.05.2013, 18.07.2013, 30.09.2013, 25.10.2013, 12.11.2013 & 11.02.2014 respectively received from different complainants. The said complaints were forwarded to District Magistrate, Giridih with a request to conduct an inspection and submit the report to ERC as early as possible.

7. AND WHEREAS the District Magistrate Officer, Giridih had submitted its report dated 29.06.2014 as well as representation dated 03.09.2014 submitted by the institution in response to show cause notice dated 18.08.2014 to ERC, NCTE. The Eastern Regional Committee in its 176<sup>th</sup> meeting held on 9<sup>th</sup> October 2014 considered the matter of the said institution and as decided by ERC, another show cause notice to the institution was issued vide No. 27748 dated 12.11.2014 on the following grounds:-

- (a) The process to increase the multipurpose hall is in under construction.
- (b) In response to the complaint, the District Magistrate, Giridih has submitted its report mentioning as follows:
  - (i) The B.N. Shah DAV Teacher Training institute and B.N. Saha DAV Public School are running in the same land and building.
  - (ii) The Separate land and building is not demarcated for B.N. Saha DAV Teacher Training institute.



- (iii) As per Inquiry report it is reported that the Principal of the institution submitted a resolution to the inquiry committee stating that one acre land out of four acres land with a four storied building (known as Dr. A.P.J. Abdul Kalam Block) has been build in the premises of BN Saha DAV Public School for the purpose running the BN Saha DAV Teachers Training Institute. But during the Physical verification there is no separate building is existing in the name of Dr. A.P.J. Kalam Block.
  - (iv) As per inquiry report both institutions are running in the same time and same building which disturbs the teaching learning atmosphere of both the institution.
- (c) Instructional and infrastructure facilities provided to the BN Saha DAV Teachers Training institute is insufficient as per NCTE Norms.
- (d) As per NCTE Regulations 2009: The society sponsoring the institution shall have to ensure that proposed teacher education institution has a well demarcated land area as specified by the norms. The teacher education institution shall not be allowed to have any other institution within its demarcated area or building and shall not have any other course(s) in its building, no other institutions can housed in the campus of any Teacher Training institution.

8. AND WHEREAS the applicant institution had submitted its representation dated 09.12.2014 in response to SCN dated 12.11.2014 to ERC, NCTE. The Eastern Regional Committee in its 179<sup>th</sup> meeting held on 22<sup>nd</sup> -23<sup>rd</sup> January 2015 after considering the records available in the file, relevant provisions of the NCTE Act 1993, Rules, Regulations and guidelines issued by NCTE Hqrs. VTR, report of the District Magistrate of Girdih (JH) and reply received on 09.12.2014 in response to the notice issued under u/s 17, the Committee discussed the matter in detail and observed as under:

- (a) The various complaints against the institution were forwarded by the NCTE Hqrs. vide letter No.A67850, A71260, A74762, A76154, A77441 & A83306 dated 28.05.2013, 18.07.2013, 30.09.2013, 25.10.2013, 12.11.2013 & 11.02.2014 respectively received from different complainants.
- (b) The said complaints were forwarded to District Magistrate, Girdih with a request to conduct an inspection and submit the report to ERC as early as possible.
- (c) The District Magistrate, Girdih submitted its report vide letter dated 29.06.2014 clarifying as follows:
  - (i) The B.N. Saha D.A.V. Teacher Training institute and B.N. Saha D.A.V. Public School, Sirsia, Girdih is running in the same campus and the timing of the classes of both institutions are same which create difficulties to the students.
  - (ii) As per record provided by the institution, the land is in the name of DAV College Managing Committee, Chitra Gupta Road, New Delhi represented by Principal, B. N. Saha D.A.V. Public School, Girdih. Hence, no land is demarcated for B.N. Saha D.A.V. Teacher Training institution. Further, the institution submitted a resolution No. 56 to the inspection team mentioning that 1 acre land having four stories building in the name of APJ Abdul Kalam Block has been given to the B.N. Saha D.A.V. Teacher Training institute out of which total 4 acre land of the B.N. Saha D.A.V. Public School. But as per physical verification, the VT team constituted by the D.M., Girdih found that no such building/block in the name of APJ

Abdul Kalam Block is constructed / established in the campus of the B.N. Saha D.A.V. Public School. It reveals that the institution has not its own separate land and building in the name of B.N. Saha D.A.V. Teacher Training institution.

(iii) In the D.M. Report, it is mentioned that the B.N. Saha D.A.V. Teacher Training institution is running in the fourth floor of the building of B. N. Saha D.A.V. Public School.

(d) Show cause notice to institution was issued on 12.11.2014 on the above grounds.

(e) Reply dated 09.12.2014 submitted by the institution is not satisfactory as per NCTE norms.

In view of the above, the committee decided as under:

The Committee concluded that the institution is running the B.Ed. course violating the NCTE Norms and Regulation 2009. The Committee, therefore, decided to withdraw the recognition of the institution for B.Ed. course under Section 17(1) of the NCTE Act, 1993 from the academic session 2015-2016.

9. **NOW, THEREFORE, grant of recognition to B. N. Saha DAV Teacher's Training College, At - Sirsia, Near Giridih Block, Giridih - Madhupur Road, Dist - Giridih, Jharkhand - 815301 (Code No. APE00581) for B.Ed. course is hereby withdrawn from the academic session 2015-2016 in terms of section 17(1) of NCTE Act, 1993.**

10. Further, if the institution is not satisfied with the order, they may prefer an appeal under Section 18 of the NCTE Act in the "Online mode" available at NCTE's website [www.ncte-india.org](http://www.ncte-india.org) within 60 days of the issue of the order.
