ORDER

WHEREAS, in terms of Section 14(1) of the NCTE Act, 1993, B.N. Saha DAV Teachers Training College, At-Sirsia, Near Giridih Block, Giridih-Madhupur Road, Dist-Giridih, Jharkhand-815301 (Code No. APE00581) was granted recognition/permission for conducting B.Ed. course vide Order No. ERC/JH-S/N-4/2005/14561 dated 18.10.2008 with 100 intake by the ERC, NCTE.

- 2. AND WHEREAS, recognition granted to B.Ed. course was withdrawn U/s 17(1) of the NCTE Act, 1993 vide Order No. ERC/179.2(ii).2/NCTE/APE00581/B.Ed./2015/30200 dated 04.02.2015 from the academic session 2015-2016, as decided in 179th ERC Meeting.
- 3. AND WHEREAS, the institution preferred an appeal to NCTE HQs., New Delhi against the withdrawal order of ERC and the Appellate Authority directed to revisit the case of the institution vide their Order No. 20404 dated 15.01.2016. The matter was considered by ERC in 208th meeting and decided to revisit the institution for B.Ed. course. Accordingly, inspection was conducted on 11.05.2016. Show Cause Notice was issued on 26.08.2016 as decided in 220th ERC Meeting. Reply received from the institution was considered by ERC in 223rd meeting and decided that the withdrawal Order dated 04.02.2015 remains unchanged as the land and building of the institution is still in the name of DAV College of Management Committee. The land and building is not in the name of B.N. Saha DAV Teachers Training Institute.
- 4. AND WHEREAS, being aggrieved with the decision of ERC, the institution preferred an appeal to NCTE HQs., New Delhi. The Appellate Authority vide Order No. 89-758/2016 Appeal/4th Meeting-2017/52431 dated 07.04.2017 remanded back the case to ERC with a direction to consider the submissions of the appellant and issue appropriate order as per the NCTE Regulations. The appellant is directed to submit all the relevant documents in this regard to the ERC within 15 days of receipt of the order on the appeal.
- 5. AND WHEREAS, the ERC in its 239th meeting (Part-1) held on 28th April to 2nd May, 2017 considered the matter and accordingly, Show Cause Notice was issued on 02.05.2017 to the institution. Due to non-compliance of SCN within stipulated period, the matter was placed in 241st ERC meeting, wherein decided that the order of withdrawal of recognition dated 04.02.2015 from the academic session 2015-2016 stands valid.
- 6. AND WHEREAS, after the decision taken in 241st ERC meeting, the reply of SCN received from the institution on 12.06.2017 was considered by ERC in 243rd meeting held on 16th -17th September, 2017 and accordingly, Show Cause Notice was issued on 27.09.2017. Reply of SCN was considered by ERC in 248th meeting and Letter of Intent u/c 7(13) was issued on 31.01.2018 to the institution. ERC in 255th meeting considered the reply of LOI, again Show Cause Notice was issued on 10.05.2018. Reply dated 28.05.2018 in response to SCN received from the institution was considered by ERC in its 257th meeting held on 2nd 3rd July, 2018.

In view of the above, the Committee decided as under:

Formal permission order under clause 7(16) of the NCTE Regulation 2014 for B.Ed. programme with an intake 100 (two basic units) with effect from the academic session

2019-2020 be issued to the institution.

- 7. NOW THEREFORE, in exercise of the powers vested under Section 14(3)(a) of the NCTE Act 1993, the Eastern Regional Committee, NCTE hereby grants recognition / permission to B.N. Saha DAW Teachers Training College, At-Sirsia, Near Giridih Block, Giridih-Madhupur Road, Dist-Giridih, Jharkhand-815301 for conducting B.Ed. Course of two years duration with an intake 100 (Two basic units) with effect from the academic session 2019-2020 under Clause 7(16) of NCTE (Recognition Norms & Procedure) Regulations, 2014 subject to fulfillment of the following conditions:-
 - I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Loan raising against or mortgaging of FDRs shall not be done.
 - II. The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.
 - III. The institution shall make admission only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations 2014.
 - IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
- 8. Further, the recognition/permission is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University / Body, the State Government etc., as applicable.
- 9. The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- 10. The institution shall maintain its website with hyperlink to the Council and the Eastern Regional Committee, covering, inter-alia, the details of the institution, its location, name of the programme applied for with intake; availability of physical infrastructure, such as land, building, office, classrooms and other facilities or amenities; instructional facilities, such as laboratory and library and the particulars of their proposed teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website, namely:
 - a) Sanctioned programmes along with annual intake in the institution;
 - b) Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph;
 - c) Name of faculty members who left or joined during the last quarter;
 - d) Names of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;
 - e) Fee charged from students;
 - f) Available infrastructural facilities;
 - g) Facilities added during the last quarter;
 - h) Number of books in the library, journals subscribed to, and additions, if any, in the last quarter;
 - i) The affidavit with enclosure submitted along with application;
 - j) The institution shall be free to post additional relevant information, If it so desires.
 - k) Any false or incomplete information on its website shall render the institution liable for withdrawal of recognition.

- The institution shall adhere to the mandatory disclosure in the prescribed format and display up-todate information on its official website.
- 12. The institution shall make available list of students admitted on its official website.
- 13. The Educational Institution shall follow Uniform Accounting System as brought out by ICAI and accepted by MHRD.
- If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made and issued there under, the institution will render itself liable to adverse action including withdrawal of recognition / permission by the Regional Committee under the provisions of Section 17(1) of the NCTE Act.
