ORDER

Change of Premises of the Institution

WHEREAS, Swami Ram Krishan Paramhansh Teacher Training College, Vill/PO – Karmatand, Dist. – Bokaro, Jharkhand – 828307 (B.Ed.) (Code No. APE00819) granted recognition for conducting B.Ed. Course with an annual intake of 100 (two basic units) from the academic session 2008-2009 vide order dated 28.02.2008.

2. **AND WHEREAS**, the aforesaid institution had submitted application dated 26.06.2014 for shifting of premises along with requisite documents.

3. **AND WHEREAS**, the ERC in its 254th meeting held on 16th – 17th April, 2018 decided that VT be constituted for shifting of premises. Accordingly, the inspection of the institution at new premises was conducted on 05-06/07/2019 and Visiting Team Report received at ERC, NCTE on 10/07/2019.


4. **AND WHEREAS**, the ERC in its 274th meeting held on 15th – 16th July, 2019 after considering and examining the application along with the documents submitted by the institution, the agenda note, the NCTE Act., the NCTE Regulations 2014 including Norms and Standards, guidelines received from the NCTE Hqs. From time to time and VTR for shifting of premises, discussed the matter in detail and decided as under:

"Shifting of the institution to its new premises i.e. Swami Ram Krishan Paramhansh Teacher Training College, Plot No. 2785, Vill.- Dugda, PO.- Karmatand, Tehsil/Taluka- Chandrapura, Town/City-Bokaro, Dist.- Bokaro, Jharkhand-828307 is permitted."
