WHEREAS, in terms of Section 14(1) of the NCTE Act, 1993, Swami Ram Krishan Paramhansh Teacher Training College, Village/P.O. – Karmatand, Dist. – Bokaro, Jharkhand – 828307 has applied for grant of recognition for B.Ed. Course (Code No. APE00819) was received by Eastern Regional Committee of NCTE on 16.05.2007.

- 2. AND WHEREAS, the institution was granted recognition for conducting B.Ed. course vide Order No. ERC/7-83.6(I).8/ 2008/102097 dated 28.02.2008 with an intake of 100 (One hundred) from the academic session 2008-2009 by the ERC, NCTE, followed by revised order issued vide No. 32706 dated 31.05.2015 as per NCTE Regulations, 2014.
- 3. AND WHEREAS, as per decision of 244th ERC Meeting, recognition granted to B.Ed. course was withdrawn under section 17(1) of NCTE Act, 1993 from the next academic session vide Order No. ER-244.17.3/APE00819/B.Ed./2017/54743 dated 18.10.2017.
- 4. AND WHEREAS, the institution preferred an appeal to NCTE HQs. and the Appellate Authority vide Order No. 89-748/E-49996/ 2017-Appeal/2nd Mtg.-2018/3 rd & 5th Feb., 2018/64139 dated 16.03.2018 remanded back the case to ERC by revisiting the whole matter in light of report of enquiry conducted by affiliating university, the proposal of shifting submitted by the appellant institution and if necessary by conducting inspection to find out the preparedness of institution to smoothly conduct the programme after assessing instructional and infrastructural capability of the appellant institution as per NCTE Regulations, 2014.
- 5. AND WHEREAS, the ERC in its 254th Meeting held on 16th 17th April, 2018 reviewed the matter in accordance with the appeal order and observed that all required documents, as submitted by the institution to the Appellate Authority, have been received.

In view of the above, the Committee decided as under:

Recognition for B.Ed. Course is continued.

6. **NOW THEREFORE**, the recognition granted to B.Ed. Course issued vide order no. ERC/7-83.6(I).8/ 2008/102097 dated 28.02.2008 is hereby continued.
