 - b. Land and Building Particulars
 - c. Staff Profile
 - d. Recognition/permission letter
 - e. Information for having fulfilled the norms & standard and other required conditions.
- 6. If the institution contravenes any of the above conditions or the provisions of the NCTE Act, Rules, Regulations and Orders made or issued there under, the Regional Committee shall withdraw the recognition/permission as under the provisions of Section 17(1) of the NCTE Act.
