WHEREAS, Sanghamitra Teacher Training College, Vill- Manatu, PO.- Ormanjhi, Tehsil/ Taluka- Ormanjhi, Dist- Ranchi, Iharkhand – 835219 (Code No. ERCAPP41) was granted recognition by ERC, NCTE on 12.09.2011 for conducting B.Ed. Course of one year duration with an annual intake of 100 from the academic-session 2011-2012 subject to fulfillment of some conditions mentioned therein.

- AND WHEREAS a Public Interest Litigation vide W.P.(PIL) No.327 of 2011 filed by Shiv Shankar Munda -Vs- Chairperson NCTE & Ors in the Hon'ble High Court of Jharkhand at Ranchi. As per direction of the Hon'ble High Court of Jharkhand, the said institution was inspected by the NCTE Hars., New Delhi under section 13 of the NCTE Act. 1993. Accordingly, the NCTE Hars: issued a deficiency letter to the institution along with the report of the Prof. Arora Committee for greater clarity of the deficiencies vide No.93-23/2014/NCTE/Insp./A85325 dated 24.03.2014 on reasons mentioned therein.
- AND WHEREAS after considering the matter in various meetings, the ERC in its 174th meeting held on 05.08.2014 considered the facts on records available in the file, the inspection report of the NCTE Hars, as well as reply submitted by the institution dated 14.07,2014 in response to ERC's show cause notice U/S 17(1) dated 17.06.2014 and as decided by ERC, withdrawn order was issued to the institution vide No.26966 dated 18.08.2014 from the academic session 2015-2016 in terms of Section 17(1) of NCTE Act 1993 on the following arounds.

The Foundation/Trust runs a school and the B.Ed. College in the same campus which (i)

is contravened to the NCTE Norms and Regulations.

As per the VT report Library is housed in a small room having seating capacity of 15 persons and not suitable for a B.Ed. college. The ICT Resource Centre has also been (ii) setup in a small room which is not fit for a computer lab. The Psychology lab set up in a class room does not have the required number of tests.

The facilities actually created for the school have been claimed to be the facilities of the B.Ed. College. Thus the institution is very deficient in terms of infrastructures and (iii)

instructional facilities.

The institution is not having a qualified Principal.

The list of the faculty submitted by the institution after the show cause notice is neither (iv) approved by the Register of the University nor having information regarding the (V) qualifications of the their eligibility as per norms.

There is not qualified regular Librarian in the institution. (vi)

AND WHEREAS the institution preferred an appeal to the NCTE Hars, against the ERC's order dated 18.08.2014. The Appellate Authority vides order No.89-364/2014-Appeal/2nd Meeting-2015/3801 dt:05.05.2015 remanded back the case to ERC with a direction to reconsider the case applying the norms laid down in NCTE Regulations, 2014.

- 6. AND WHEREAS the ERC in its 191st meeting held on 14-15 July 2015 considered the reply of the institution dated 23.05.2015 in response to ERC letter dated 30.05.2015, decided as under:
 - (i) Recognition be continued
 - (ii) The institution is required to submit the Experience Certificate of Principal.
- 7. NOW THEREFORE, the recognition of the institution viz. Sanghamitra Teacher Training College, Vill- Manatu, PO.- Ormanihi, Tehsil/ Taluka- Ormanihi, Dist- Ranchi, Jharkhand 835219 (Code No. ERCAPP41) is allowed to continue.
