ORDER

- Approved building completion certificate by the concerned competent Govt. Engineer/Authority.
- FDRs towards Endowment fund and Reserve fund after conversion into joint operation mode as prescribed in the NCTE Regulations, 2014.
- Confirmation on website updates of the institutions with all details along with affidavit.

3. **AND WHEREAS**, the ERC in its 271st Meeting held on 24th – 25th April, 2019 considered the matter and as decided, another Show Cause Notice u/s 17(1) was issued on 18.05.2019.

4. **AND WHEREAS**, the ERC in its 274th meeting held on 15th – 16th July, 2019 considered the matter and observed as under:

1st show cause notice u/s 17(1) issued on 20.04.2018, followed by final show cause notice dated 18.05.2019 on the following grounds:-

- Approved faculty list by the concerned affiliating body along with requisite documents.
- Approved building plan by the concerned competent Govt. Engineer/Authority.
- Approved building completion certificate by the concerned competent Govt. Engineer/Authority.
