**Order**

In terms of Section 14(1) of the NCTE Act, 1993 Primary Teacher's Education College cum DIET, Latehar, Jharkhand, Pin - 829206 had submitted an application to the Eastern Regional Committee of NCTE for grant of recognition for starting PTT Course of two years duration from the academic session 2004-2005 with an annual intake of 200 (two hundred) students.

2. On scrutiny of the application submitted by the institution, the documents attached therewith, the inputs received from the visiting team, the Committee has noted the following:

- i) The institution has acquired the land for setting up the teacher education institution.
- ii) The institution has constructed the building for conducting the course on the above mentioned land.
- iii) The institution has selected the 3 (three) teachers for the said course and the list of faculty members has not been approved by the affiliating body i.e. Jharkhand Academic Council, Ranchi.

3. Now, therefore, in exercise of the powers vested under Section 14(3) (a) of the NCTE Act, 1993, the Regional Committee hereby grants recognition to **Primary Teacher's Education College cum DIET, Latehar, Jharkhand, Pin – 829206** for PTT Course of two years duration from the academic session **2005-2006** with an annual intake of **100 (one hundred)** students subject to fulfillment of the following:

- a) That the institution shall appoint regular qualified Principal/ Head and at least 10 qualified as per NCTE norms immediately and ensure that Principal and at least 10 (ten) faculty members duly approved by the affiliating body are in position for an intake of 100 students before the commencement of the course and a report to this effect shall be sent to the Eastern Regional Committee before the commencement of the course.
- b) The institution will ensure availability of Psychology laboratory, Educational Technology laboratory as per NCTE norms immediately and a report to this effect shall be sent to the Eastern Regional Committee before commencement of the course.
- c) The institution shall comply with the various other norms and standards prescribed in the NCTE regulations.

4. Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC, the State Government etc.
5. The institution shall submit to the Regional Committee a Performance Appraisal Report at the end of each academic year along with a copy of the approval of the affiliating body to the appointment of faculty members, and the statement of annual accounts duly audited by a Chartered Accountant.
6. If the institution contravenes any of the above conditions or any of the provisions of the NCTE Act, Rules, Regulations and Orders made or issued thereunder, the Regional Committee may withdraw the recognition under the provisions of Section 17(1) of the NCTE Act.
