ORDER

WHEREAS, in terms of Section 15(1) of the NCTE Act, 1993, Rishikesh Mahato Memorial Public Educational Trust, Vill:- Sahubahiyar, Street / Road:- NH-2, Taluka/ Mandal:- Topchanchi, Town/City:- Sahubahiyar, Dist:- Dhanbad, Jharkhand-828404 has applied for grant of recognition/permission to Binod Bihari Mahato Memorial Teachers' Training College, Vill:-Sahubahiyar, Street / Road:- NH-2, Taluka/ Mandal:- Topchanchi, Town/City:- Sahubahiyar, Dist:- Dhanbad, Jharkhand-828404 (Code No. ERCAPP201645066) (ID No. 8906) for D.El.Ed. Course online on 27-05-2016 for two year duration and hard copy received by Eastern Regional Committee of NCTE on 02-06-2016.

- 2. **AND WHEREAS**, on scrutiny of the application submitted by the institution, the documents attached therewith, the affidavit submitted and the report received from VT and videography, and the certificates received from the affiliating body, the Committee is satisfied that the applicant fulfils the requirements under the provisions of NCTE Act, Rules and relevant Regulations including the Norms and Standards for the said teacher education programme such as instructional facilities, infrastructural facilities, financial resources, etc., for running the programme.
- 3. **AND WHEREAS**, the institution was granted permission for D.El.Ed. course with an intake of 100 (two basic units) from the academic session 2019-2020 vide Order No. ER-255.6.18/ID No.-8906/D.El.Ed./2018/56915 dated 10.05.2018 by the ERC, NCTE.
- 4. **AND WHEREAS**, being aggrieved, the institution filed W.P. No 566 of 2018 in the Supreme Court of India. The Hon'ble Supreme Court passed an interim Order dt. 21.06.2018 along with other cases with following directions:

"Pursuant to the order dated 04.06.2018, the petitioner is permitted to file a representation for grant of recognition for the academic year 2018-2019 within two days from today. Respondent No. 1 is directed to consider the said representation within a period of ten days from today. The petitioner may be permitted to participate in the counselling for the academic session 2018-2019."

5. AND WHEREAS, the institution submitted representation dt. 23.06.2018 received on 25.06.2018 along with the order passed by the Hon'ble Supreme Court. Direction received from NCTE Hars., New Delhi vide e-mail/letter vide No. F.63-13/2018/NCTE/Legal dated 28.06.2018 as under:

The petitioner submitted representation which is received at NCTE (HQ) on 25.6.2018 evening for recognition for academic year 2018-2019. The RD, ERC to issue recognition order in compliance of Hon'ble Court Order immediately on or before 30.6.2018.

6. **AND WHEREAS**, the ERC in its 257th meeting held on 2nd – 3rd July 2018, re-viewed the matter in accordance with above and decided as under:-

"Formal permission order under clause 7(16) of the NCTE Regulation 2014 for applied D.El.Ed. programme with an intake 100 (two basic units) from the academic session 2018-2019 instead of 2019-2020 be issued to the institution".

- 7. NOW THEREFORE, in exercise of the powers vested under Section 15(3)(a) of the NCTE Act 1993, the Eastern Regional Committee, NCTE hereby grants recognition/permission to Binod Bihari Mahato Memorial Teachers' Training College, Vill:- Sahubahiyar, Street / Road:- NH-2, Taluka/Mandal:- Topchanchi, Town/City:- Sahubahiyar, Dist:- Dhanbad, Jharkhand-828404 for conducting D.El.Ed. Course of two years duration with an intake 100 (two basic units) from the academic session 2018-2019 instead of 2019-2020 under Clause 7(16) of NCTE (Recognition Norms & Procedure) Regulations, 2014 subject to fulfillment of the following conditions:-
 - I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Loan raising against or mortgaging of FDRs shall not be done.
 - II. The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.
 - III. The institution shall make admission only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations 2014.
- IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
- 8. Further, the recognition/permission is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University / Body, the State Government etc., as applicable.
- 9. The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- 10. The institution shall maintain its website with hyperlink to the Council and the Eastern Regional Committee, covering, inter-alia, the details of the institution, its location, name of the programme applied for with intake; availability of physical infrastructure, such as land, building, office, classrooms and other facilities or amenities; instructional facilities, such as laboratory and library and the particulars of their proposed teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website, namely:
 - a) Sanctioned programmes along with annual intake in the institution;
 - b) Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph;
 - c) Name of faculty members who left or joined during the last quarter;
 - d) Names of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.:
 - e) Fee charged from students;
 - f) Available infrastructural facilities;
 - g) Facilities added during the last quarter;
 - h) Number of books in the library, journals subscribed to, and additions, if any, in the tast quarter;
 - i) The affidavit with enclosure submitted along with application;
 - i) The institution shall be free to post additional relevant information, If it so desires.
 - k) Any false or incomplete information on its website shall render the institution liable for withdrawal of recognition.

- 11. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.
- 12. The institution shall make available list of students admitted on its official website.
- 13. The Educational Institution shall follow Uniform Accounting System as brought out by ICAI and accepted by MHRD.
- 14. If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made and issued there under, the institution will render itself liable to adverse action including withdrawal of recognition / permission by the Regional Committee under the provisions of Section 17(1) of the NCTE Act.
- 15. Recognition order issued earlier vide letter No. ER-255.6.18/ID No.-8906/D.El.Ed./2018 /56915 dated 10.05.2018 may be treated as cancelled.
